Two of four Covert X helmets tested during a random sample test on February 17, 2023 by NHTSA at a contracted test lab for motorcycle helmets were found non-compliant with the retention system requirement set forth in FMVSS No. 218.

After receiving information from NHTSA via its letter dated May 10, 2024 regarding several potentially noncomplying helmets, Kido immediately implemented an action plan and conducted an internal investigation into the potential non-compliance with FMVSS No. 218 pertaining to all sizes of the Covert X helmets and HD-X07 helmets. On June 13, 2024, which is the date that Kido acknowledged receipt of NHTSA's letter, although Kido is unable to determine the exact time period of the affected helmets, based on its diligent search and investigation, Kido determined that the retention system for the Covert X produced between September 2021 through January 2024 and HD-X07 produced between July 2021 through February 2024 may be noncompliant with FMVSS No. 218. Kido decided to implement a voluntary recall of all sizes of the Covert X and HD-X07 helmets produced during the aforementioned time period.

The subject component was manufactured by two distinct entities during the relevant time period. In addition to the aforementioned component manufacturer, Qingdao Chunqi Knitting Co., Ltd., the second component manufacturer is identified below:
