Enclosed are copies of letters dated in the year 2004 and addressed to Toyota headquarters in California where I had a claim regarding my 1997 Avalon and over-acceleration.

The dealer at St. Augustine requested I come get the car. I refused to drive it, went across the highway to Honda and in arranging for a trade, the Honda salesman drove my car from Toyota to Honda. He told me the next day that the Avalon, that morning, had revved up to 90 mph. In other words, Toyota St. Augustine had not repaired the car.

When my Avalon over-accelerated I, indeed, had my foot on the brake. Two cars plus mine were damaged.

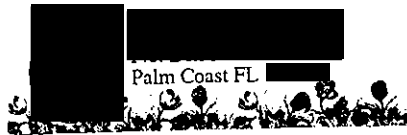
I review this information for you in light of recent problems with Toyota. Headquarters would not admit a problem.

On February 23, 2004, my '97 Toyota Avalon over-accelerated and surged forward in a parking area, damaging two parked vehicles. (No injuries – no citation.)

I have written evidence from the Dealer that carbon in the engine and a particular valve could have caused over-acceleration. This car has a history of a replaced EGR Valve Assembly in March of '02.


The accident was in my opinion serious and potentially life-threatening.

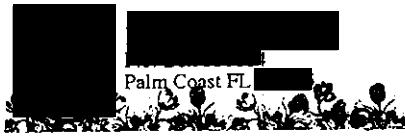
Can you provide me with any statistics about recalls for this problem or accidents caused by this problem?

Dear Ms. Hargrave:

When I sent you correspondence with attachments regarding an accident with my '97 Avalon, I was not seeking any benefits from Toyota. My major concern is that the average car owner would not know to tell a Toyota service department to "clean the fuel injectors." You stated in my call to you that this problem would be between the dealer and me.

Toyota St. Augustine, Florida has a large printed sign in its garage listing its "menu" of preferred service at certain mileage. I followed all of this as my record there would show. When my car was driven from that lot, the problem with the injectors had not been corrected.

I enclose a local article about a car accident where there was bodily injury, this being a Ford Escort. Follow-up information tells me this was over-acceleration. God help the elderly driver.

I loved the Avalon and this was the only accident in my long driving career.
