Thank you for your correspondence dated August 12, 2004, concerning the problems you have encountered with Firestone Steeltex, size LT225/75R16, tires that were installed on your 2000 Shasta Class C motorhome. Your correspondence was received on August 19, 2004. Due to limited resources we were not able to respond to you in a more timely manner. We regret any inconvenience our delay may have caused you.

The National Highway Traffic Safety Administration (NHTSA) is the Federal agency responsible for improving safety on our Nation's highways. We are authorized to order manufacturers to recall and repair vehicles or items of motor vehicle equipment when our investigations indicate that they contain serious safety defects in their design, construction, or performance. In order for the agency to initiate an investigation, we look carefully at the body of consumer complaints and other available data to determine whether a defect may exist. We cannot act on isolated problems or resolve disputes between individual owners, dealers, or manufacturers.

We appreciate the report you provided. Reports from motorists are a very important source of information for us. Each report is analyzed and entered into a database to help us determine whether an investigation into a possible safety defect is warranted.

NHTSA's Office of Defects Investigation (ODI) closed an investigation (PE00-040) into tire failures involving Firestone Steeltex R4S, R4S II, and A/T light truck radial tires on April 9, 2002. A copy of the resume and closing report for this investigation are enclosed for your information. In November 2002, the Law Offices of Lisoni & Lisoni and the Law Offices of Steven E. Weinberger petitioned NHTSA to reopen its investigation (DP02-011). On June 16, 2003, ODI denied that petition after conducting a thorough analysis of information submitted in support of the petition, data in our own database, and information obtained from Bridgestone/Firestone, Inc. (Firestone). The petition resume and the analysis presented in the Federal Register notice regarding the denial of that petition are also enclosed for your information.


On May 12, 2004, ODI received two additional petitions from the Law Offices of Lisoni & Lisoni. In the first petition (DP04-004), the petitioner requested that NHTSA reopen its previous defect investigation into all Firestone Steeltex light truck radial tires. In the second petition (DP04-005), the petitioner requested that NHTSA open an investigation into Steeltex tires used on ambulance and emergency response vehicles. On September 28, 2004, ODI denied both petitions after conducting a thorough analysis of information submitted in support of the petition, data in our own database, and updated information obtained from Firestone. The petition resumes and the analysis presented in the Federal Register notice regarding the denial of these petitions are also enclosed for your information.

One of our representatives may be able to assist you on matters concerning motor vehicle and motor vehicle equipment safety recalls or to report an alleged safety problem. You can also request safety information. If our telephones are busy, or you call during non-working hours, you can leave your name, telephone number, and a brief subject on our recording system. A DOT Hotline representative will return your call.

This form is for vehicle owners to report safety related problems about their motor vehicles or motor vehicle equipment, e.g., child safety seats, jacks, tires, brake fluid, etc. The reports submitted are transferred to our database and are used to identify safety-related defect trends that require our attention. If you do not have access to the Internet, please use the enclosed VOQ to inform this agency of any future motor vehicle or motor vehicle equipment safety problems you may experience.
