We received your correspondence dated July 8, 2005, concerning 1996 Plymouth Breeze. It was received by the Office of Defects Investigation (ODI) on July 24 2005. Due to limited resources we were not able to respond to you in a more timely manner. We regret any inconvenience our delay may have caused you.

The National Highway Traffic Safety Administration (NHTSA) is the Federal agency responsible for improving safety on our Nation's highways. We are authorized to order manufacturers to recall and repair vehicles or items of motor vehicle equipment when our investigations indicate that they contain serious safety defects in their design, construction, or performance. We also monitor the adequacy of manufacturers' recall campaigns. In order for the agency to initiate an investigation, we look carefully at the body of consumer complaints and other available data to determine whether a defect may exist. We cannot act on isolated problems or resolve disputes between individual owners, dealers, or manufacturers.

With regard to corrective action for the recall (NHTSA Campaign No. 04V-021000, summary enclosed) a copy of your correspondence was provided to ODI's Defect Assessment Division (DAD). DAD has advised the Daimler/Chrysler, Inc. concerning the problem you have experienced in having the corrective action accomplished and requested that appropriate action be taken.

One of our representatives may be able to assist you on matters concerning motor vehicle and motor vehicle equipment safety recalls or to report an alleged safety problem. You can also request safety information. If our telephones are busy, or you call during non-working hours, you can leave your name, telephone number, and a brief subject on our recording system. A Hotline representative will return your call.
