Thank you for your correspondence dated July 28, 2005, concerning your 2002 Ford Focus. Your correspondence was forward to The National Highway Traffic Safety Administration (NHTSA), Office of Defects Investigation (ODI) by the Department of Justice, Office of Consumer Litigation. It was received on August 19, 2005. Due to limited resources we were not able to respond to you in a more timely manner. We regret any inconvenience our delay may have caused you.

NHTSA is the Federal agency responsible for improving safety on our Nation's highways. We are authorized to order manufacturers to recall and repair vehicles or items of motor vehicle equipment when our investigations indicate that they contain serious safety defects in their design, construction, or performance. We also monitor the adequacy of manufacturers' recall campaigns. In order for the agency to initiate an investigation, we look carefully at the body of consumer complaints and other available data to determine whether a defect may exist. We cannot act on isolated problems or resolve disputes between individual owners, dealers, or manufacturers.

We appreciate the report you provided. Reports from motorists are a very important source of information for us. Each report is analyzed and entered into a database to help us determine whether an investigation into a possible safety defect is warranted.

The Ford Motor Company recalled the 1998 through 2001 Taurus and Sable vehicles due to front end failures. We reviewed our database complaint file in an effort to identify whether a safety defect trend exists with regard to problems associated with the front coil suspension system in 2002 Ford Focus vehicles. At this time, there is insufficient evidence to warrant opening a safety defect investigation. The information you provided has been entered into our database. It will be considered with other reports to identify any safety defect trends that may require our attention.

If you do not have access to the Internet, please use the enclosed VOQ to inform this agency of any future motor vehicle or motor vehicle equipment safety problems you may experience.
