Thank you for your correspondence that was received by the National Highway Traffic Safety Administration's (NHTSA) Office of Defects Investigation (ODI), on November 30, 2005, concerning 1996 Volkswagen Passat. Due to limited resources available, we were not able to respond to you in a timelier manner. We regret any inconvenience our delay may have caused you.

NHTSA is the Federal agency responsible for improving safety on our Nation's highways. We are authorized to order manufacturers to recall and repair vehicles or items of motor vehicle equipment when our investigations indicate that they contain serious safety defects in their design, construction, or performance. We also monitor the adequacy of manufacturers' recall campaigns. In order for the agency to initiate an investigation, we look carefully at the body of consumer complaints and other available data to determine whether a defect may exist. We cannot act on isolated problems or resolve disputes between individual owners, dealers, or manufacturers.

We appreciate the report you provided. Reports from motorists are a very important source of information for us. Each report is analyzed and entered into a database to help us determine whether an investigation into a possible safety defect is warranted.

We have reviewed our database with regards to the failure of the replacement of the ignition switch in NHTSA's recall 02V-256000 (summary enclosed). At this time, there is insufficient evidence to warrant opening an inadequate recall investigation. The information you provided has been entered into our database. It will be considered with other reports to identify any safety defect trends that may require our attention.

This form is for vehicle owners to report safety related problems about their motor vehicles or motor vehicle equipment, e.g., child safety seats, jacks, tires, brake fluid, etc. The reports submitted are transferred to our database and are used to identify safety-related defect trends that require our attention. If you do not have access to the Internet, please use the enclosed VOQ to inform this agency of any future motor vehicle or motor vehicle equipment safety problems you may experience.
