Thank you for your correspondence dated November 29, 2005, concerning your 1999 Honda Civic. Your correspondence was received by the National Highway Traffic Safety Administration's (NHTSA) Office of Defects Investigation (ODI) on January 4, 2006. Due to limited resources we were not able to respond to you in a more timely manner. We regret any inconvenience our delay may have caused you.

NHTSA is the Federal agency responsible for improving safety on our Nation's highways. We are authorized to order manufacturers to recall and repair vehicles or items of motor vehicle equipment when our investigations indicate that they contain serious safety defects in their design, construction, or performance. We also monitor the adequacy of manufacturers' recall campaigns. In order for the agency to initiate an investigation, we look carefully at the body of consumer complaints and other available data to determine whether a defect may exist. We cannot act on isolated problems or resolve disputes between individual owners, dealers, or manufacturers.

We appreciate the report you provided. Reports from motorists are a very important source of information for us. Each report is analyzed and entered into a database to help us determine whether an investigation into a possible safety defect is warranted.

We are enclosing a copy of America Honda Motor Co. Inc. letter, dated May 23, 2002, that identifies the vehicles recalled (NHTSA Recall Number 02V-120). Please note that your vehicle is not among those that were recalled. Additionally, a review of our database relative to problems associated with the ignition switch in 1999 Honda Civic vehicles revealed insufficient evidence to warrant expanding the scope of that recall at this time. The information you provided has been entered into our database. It will be considered with other reports to identify any safety defect trends that may require our attention.

Regarding your request for reimbursement this does not fall under our jurisdiction. If you have not done so, you may consider contacting your local Consumer Protection Agency, Better Business Bureau, or the Ohio Office of the Attorney General regarding your request.

If you do not have access to the Internet, please use the enclosed VOQ to inform this agency of any future motor vehicle or motor vehicle equipment safety problems you may experience.
