Dear Mr. Vincent:

We are in receipt of your recent correspondence and ask that you consider the following claims made by Mr. Thieret:

1. The vehicle was represented as a lease vehicle. It was not.
2. There are still 4 years remaining on the note. The vehicle should have been able to pay for itself. It is unable to perform as a business vehicle, resulting in lost fees and commissions.
3. Over \$7,000 has been invested in repairs; which have failed to fix problems that should have been fixed prior to delivery.


Despite the problems associated with his purchase [REDACTED] has been more than satisfied with International in the past and desires to continue the relationship in the future.
