At 1427 hours, I met with [REDACTED] on station in reference to damage to his property. [REDACTED] claimed that his power steering in his vehicle failed and caused his car to lock up. [REDACTED] drives a red 2006 Honda Civic, IL plate [REDACTED]. On 09/26/2006 at approximately 1330 hours, [REDACTED] claimed he was traveling west on third street at approximately 20-25 mph near 720 E. 3rd Street when all of a sudden his power steering went out causing his steering to lock up and turn the car to the right. [REDACTED] claimed that his vehicle ran into a tree. [REDACTED] stated there was damage to the front bumper and left front corner of the vehicle. [REDACTED] did not have his vehicle with him, so I could not inspect it. [REDACTED] also claimed that he called Steven's Honda in early September to report problems with his power steering. [REDACTED] stated that Steven's Honda advised him it was ok to drive the vehicle.
