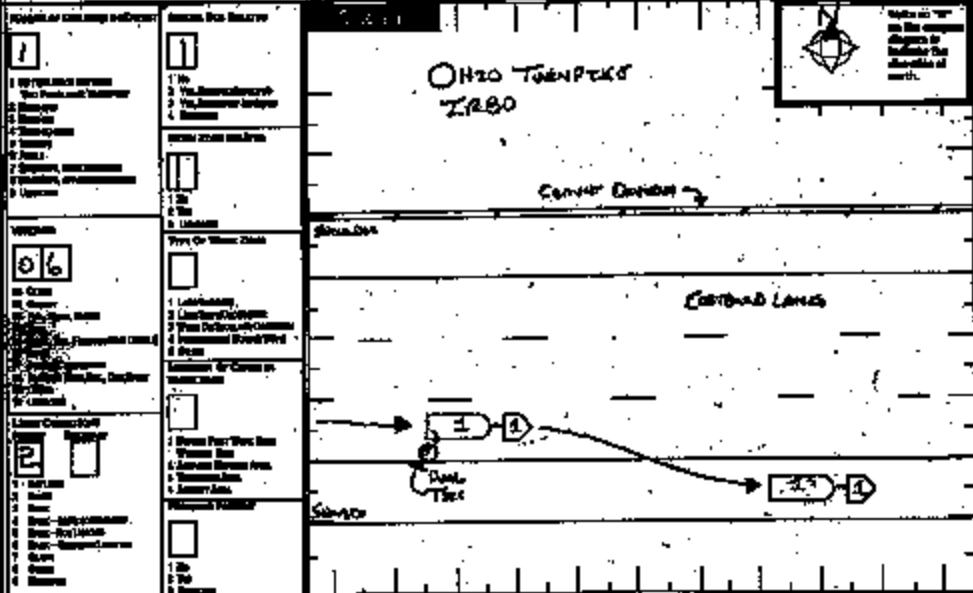


UNIT #1 WAS TRAVELING EAST BOUND ON THE
