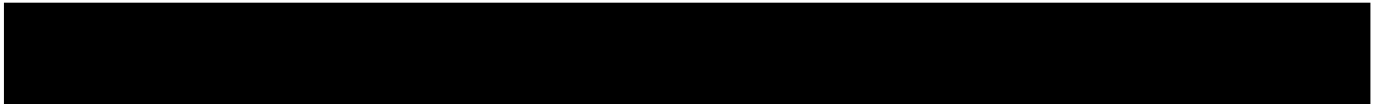

The LICENSE (Certificate of Ministry) which grants the right to PREACH AND TEACH only. Those who hold the Minister's License cannot perform weddings, communions, baptisms, etc. under this license. THIS LICENSE IS ISSUED TO MINISTERS WHO ARE JUST GETTING STARTED IN THEIR MINISTRY; those who are incarcerated and approved by an ordained Chaplain, the ones who work in hospitals, convalescent homes, personal witnessing, youth pastors, etc. IT IS OUR CHOICE THAT ALL WHO RECEIVE A MINISTER'S LICENSE WORK UNDER A SENIOR PASTOR FOR SIX MONTHS TO A YEAR.

ALL MINISTERS WHO GIVE PERSONAL COUNSELING NEED TO BE SURE IT IS LEGAL IN YOUR STATE. Some states require a special Counselor's License before a minister can serve in this office.

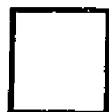

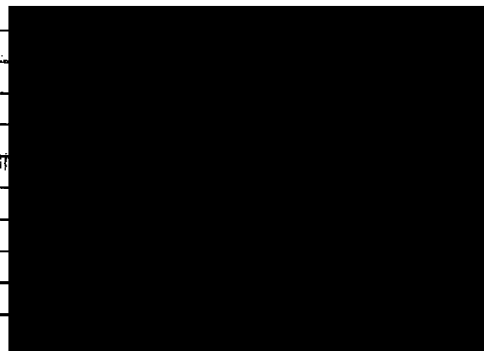
