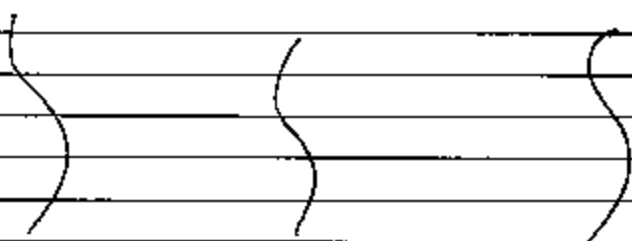

I WAS EASTBOUND ON THE OTHER TURNPIKE. I WAS IN THE LEFT LANE CATCHING UP TO A SEMI. I WAS GOING 65 OR 66 MPH. WHEN I WAS 50 TO 75 YARDS BEHIND THE SEMI A TIRE BLEW OUT ON THE LEFT SIDE OF THE SEMI AND A PIECE OF THE SEMI'S BATTERY BOX HIT THE FRONT OF MY CAR AND PIECES OF RUBBER STUCK TO THE FRONT AND RIGHT SIDE OF MY CAR. WE BOTH PULLED OVER ONTO THE RIGHT BEAM.
