ON MARCH 5, 2008, THE CONTACT RECEIVED A FORD SAFETY RECALL FOR THE VEHICLE SPEED CONTROL. THE PURCHASE DATE AND RECALL NUMBER WERE UNKNOWN. THE CURRENT AND FAILURE MILEAGES WERE 100,000.
