Thank you for your correspondence dated March 24, 2008, concerning the problems you encountered with your model year (MY) 2005 Fleetwood Pegasus fifth wheel. Your correspondence was received by the National Highway Traffic Safety Administration's (NHTSA) Office of Defects Investigation on April 3, 2008.

NHTSA is the Federal agency responsible for improving safety on our Nation's highways. We are authorized to order manufacturers to recall and repair vehicles or items of motor vehicle equipment when our investigations indicate that they contain serious safety defects in their design, construction, or performance. However, we cannot act on isolated problems or resolve disputes between individual owners, dealers, or manufacturers.

We appreciate the report you provided. Reports from motorists are a very important source of information for us. A review of our database relative to problems associated with a crack in the sealant and water leaking from the skylight into the bathroom causing water damage in MY 2005 Fleetwood Pegasus fifth wheels revealed no other reports of problems similar to that which you encountered; therefore, there is insufficient evidence to warrant opening a safety defect investigation at this time. The information you provided has been entered into our database and will be considered with future reports to identify any safety defect trends that may require our attention.

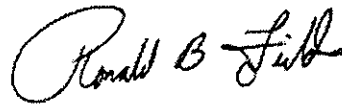
We sympathize with you concerning your request for Fleetwood to repurchase the vehicle; however, this type of request does not fall under our jurisdiction. NHTSA cannot assist vehicle owners in obtaining reimbursements. We can only recommend you continue to work with Fleetwood regarding your request. We regret that we cannot assist you further in this matter. If you have not done so, you may consider contacting your local Consumer Protection Agency, Better Business Bureau, or the Pennsylvania Office of the Attorney General regarding your request.
