Please note that I am holding AC Delco and General Motors 100% liable should any accident or death or injury occur from an acceleration issue with the AC Delco Part Number 213-2820 installed in my 2002 AM General H1 Hummer and it is documented that this is my third replacement within 2 and a half years. The second pedal failed after 12 months and 2 days and this one failed 14 or so months after purchase. ALL pedals were purchased by AC Delco in Sparks, Nevada and ALL were installed at Winkel Hummer in Reno, Nevada. The issue is rapid acceleration while driving or trying to stop. It is further documented that I have had 3 (THREE) near accidents, two of which were close call situations, as a result of this defect or failure of the AC Delco Accelerator Pedal. It is further documented that a representative from AC Delco was NO HELP, gave mis-information and was not customer service friendly over a serious issue.

Also, there are documented failures of other GM made vehicles with the SAME ISSUES. As told to me by the AC DELCO representative, this is a common part used in other vehicles. This issue also occurred in my 1999 AM General Hummer as well !!!!!!!

THIS IS A VERY SERIOUS ISSUE AND UNLESS AC DELCO FOLLOWS THROUGH WITH ME TO MY UTMOST SATISFACTION, I WILL ESCALATE THIS.
