Not realizing the proper protocol, I sent this to Mr Mika's office first.
NHTSA has an open defect investigation re Bluebird motorhomes and has had 17 owners respond that the recall failed; some with proof that the units are overweight. There have been 3 tire failure accidents, one fatal. Bluebird has had 2 jury trials with verdicts of consumer fraud and has settled 3 other cases out of court. One of these was wrongful death.
