Unfortunately, my vehicle did ignite. The incident occurred in a parking lot at Southland Mall in Taylor, Michigan on March 3, 2011. Area Towing and Recovery towed it from the site. Enclosed with this letter is a copy of their documentation. Furthermore, I am receiving monthly bills for accrued storage fees from Area Towing and Recovery, which, as of this month, total \$1,228.00. Enclosed with this letter is a copy of their last bill.

The Blue Book value of my car is \$2,455.00. Of course, I expect compensation for my automotive loss and the delinquent storage fees, which are negatively affecting my credit rating. Therefore, I am looking forward to hearing from you regarding a settlement.
