**Nitto Mud Grapplers splitting up the sidewall**

If you are running Mud Grapplers - keep an eye on them!

If you've read any posts on here by me about tires, its no secret that I LOVE my Mud Grapplers. They have been the best tire I have ever owned, super puncture resistant - I had a mesquite thorn go through the front of my fender flare but have yet to have one pierce a Grappler - only flat I've had, I found like 6 nails in one. They've been awesome on every surface - rocks, mud, sand, snow and ice.

yeah they're noisy on the road, but you get used to it, they chunk a little on the rocks but nothing like a swamper, and yeah they are expensive but they wear great on my 4dr.

**BUT**

2 of mine have split up the sidewall from the side lugs - not just one or 2 little cracks, but numerous canyons on both sides of the tires, to the point that one will leak pretty severely if parked with a split facing down.

I contacted Nitto and got the standard "contact your dealer" form email. So I took it to the local Discount Tire and they said the only time they had seen that was on 3/4 ton trucks doing burnouts on the street. Definitely NOT something my minivan motor can do. They called Nitto and the response was just "prorate a new pair of tires based on tread depth" no explanation or anything. so I could have had a new pair of tires for ~ half price, but since they were all about half worn, I still would have had to pay full price for the other 3 and no explanation about the cracks - if they were likely to do it again or anything. Yeah I have about 35K miles on them, but if it werent for the cracks, they have an easy 15-20K left on them. BTW - I keep my pressure at about 33psi on the street and rotate them semi- regularly, not as often as I should have but its been done a few times.

So keep an eye on your side lugs if you run Grapplers - these cracks didnt start showing until they had about 30K miles on them. heres a pic of one of the cracks - and not the worst one The 2 tires in question have probably 8-12 cracks PER SIDE! the one that actually leaked, you could stick your pinky finger tip into the crack when it was facing down.

I, [REDACTED], purchased these tires (Mud Grapplers) on 3/28/2009 during the time of purchase and the tire failure the tires only had just over 14,000 miles on them, after the failure had occurred and installing the spare tire I made an unnerving discovery on the inside wall of the tire I had removed, it had approximately eleven cracks all the way around the tire all about the same size as the one show in the attachment, attached to this e-mail. Please note not only the tire that had failed had cracks, but the remaining three still on the vehicle had the same kind of cracks in the inside side walls. Toyo Tire Holdings of Americas has recalled certain types of their NITTO TERRA GRAPPLER TIRES for the same reason, why have they not recalled the MUD GRAPPLER?? I have attached the document NITTO/TOYO TIRE RECALL ALERT concerning the recall; I have also attached a document from the JKO Owners.Com Web Site stating a warning of the NITTO MUD GRAPPLER TIRE splitting up the sidewalls. It concerns me deeply that TOYO/NITTO is fully aware that the MUD GRAPPLER TIRE has the same defect as the certain NITTO TERRA GRAPPLER tires, but as far as I know has not recalled the MUD GRAPPLER TIRE. They're very well could be people out there that have these MUD GRAPPLER TIRES on their vehicles and are not aware of the danger of the inside walls of their tires splitting up the side walls, let's be honest how many people check the inside side walls of their tires on a regular basis, if at all. This is a serious issue and someone could be seriously injured or killed because they may not be aware of the MUD GRAPPLER TIRE DEFECT, mainly because Toyo Tire Holdings of Americas has not recalled this tire, as they did with the NITTO TERRA GRAPPLER TIRE with the absolute same problem. It seems to be quite odd that the Toyo Tire Company has recently changed the way manufacture the MUD GRAPPLER TIRE; they have gone to manufacturing the tire in a metric size 31517516. Could it be because of the defect in the original manufacturing process?? Either way I think the Toyo Tire Company is being extremely irresponsible about this matter and is a dollar amount worth more than someone's life if a fatal accident did occur because of the defected tires that have not been recalled.
