Incident Description: 2008 Maserati engine self ignited inside garage after it was stowed for the night on 10/30/2012. Friend saw smoke billowing from our garage, when we opened it, the car engine was on fire. 911 was called, we tried unsuccessfully to use a fire extinguisher and hose. Car is totaled. We have video and pictures of the fire and car. Entire inside of garage is damaged, as well as second floor gym/art room/storage and roof. We were lucky the fire did not reach the gas tank and explode. No life lost. This is the second incident of Park Place Maserati cars in Dallas since June, 2012. In both cases, Maserati told us and other owners, "you are on your own", were perplexingly distant, uninterested and antagonistic. The dismissive attitude of Maserati makes us very concerned about future Maserati owners and their safety.
