Thank you for your correspondence concerning your model year (MY) 2006 BMW 750Li. The National Highway Traffic Safety Administration's (NHTSA) Office of Defects Investigation received your correspondence. We regret any inconvenience our delay in responding may have caused you.

NHTSA is the Federal agency responsible for improving safety on our Nation's highways. We are authorized to order manufacturers to recall and repair vehicles or motor vehicle equipment when our investigations indicate that they contain safety defects in their design, construction, or performance. We also monitor the adequacy of manufacturers' recall campaigns. In order for the agency to initiate an investigation, we look carefully at the body of consumer complaints and other available data to determine whether a defect trend may exist. We do not have authority to act on isolated problems or resolve disputes between individual owners, dealers, or manufacturers.

You indicate noticing that the front passenger seat is separating in the back of your MY 2006 BMW 750Li. You state that you are disturbed that such a problem can occur based on your light use of the vehicle.

We have reviewed our database in an effort to identify whether a safety defect trend exists with regard to the front seat backs separating in MY 2006 BMW 750Li vehicles. At this time, there is insufficient evidence to warrant opening a safety defect investigation. The information you provided has been entered into our database. It will be considered with future reports to identify any safety defect trends that may require our attention. We understand the passenger seat back separating is frustrating, however, this type of problem does not fall under our jurisdiction. For your information, the Federal Trade Commission (FTC) has jurisdiction over non-safety defects, paint, fraud or deception, warranty and dealership problems, remuneration matters, and fair trade practices.
