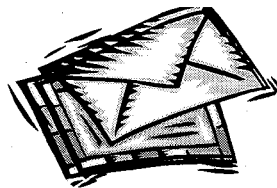

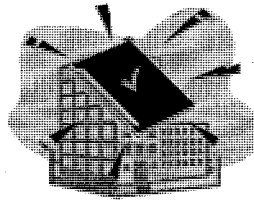

Bombardier Recreational Products (BRP) is the manufacturer of a very popular three wheel motorcycle called the CanAm Spyder. BRP has discovered a serious problem with the 2013 RT and RS model Spyders that can result in the machine bursting into flames. Transportation Canada has issued a recall for all 2013 roadsters in Canada, but the National Highway Transportation Safety Administration has, to date, failed to issue a recall in the USA. Please ask the NHTSA to expedite this serious issue and issue the US recall so owners of the effected Spyder Roadster can be repaired by US dealers before someone is seriously injured or killed.
