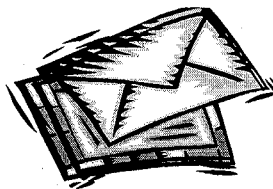

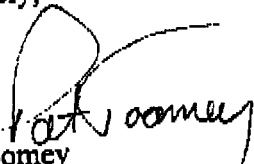
Dear Ms. Gresham,
