Narrative Description of Incident(s), Failure(s), Crash(es), and Injury(ies)

In January, 2014, Chrysler Group LLC notified me of a safety recall NHTSA 13V-529 involving a defective left tie rod ball stud that could fracture. When I called Oveido Dodge in LaGrange, Texas, they informed me that they had not received parts from Chrysler to make the repairs. They put me on a waiting list. I called again 2-3-14 with the same answer, & called again in April. I called for the 4th time 5-3-14 & also called Benny Boyds Dodge in Bastrop & got on their list. To date, (6-13-14), I have not received any calls indicating that parts are available. The Dodge truck is used to haul heavy loads (trailers & RVs).
