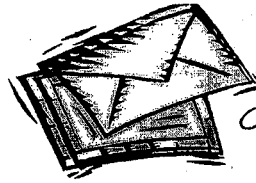


Dear Mr. Gresham:
