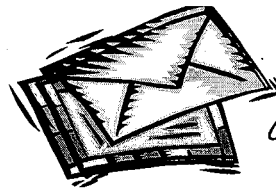

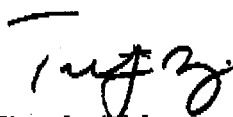
Dear Ms. Gresham:

This is a safety recall involving fire and possible death. I want this recall complied with immediately.

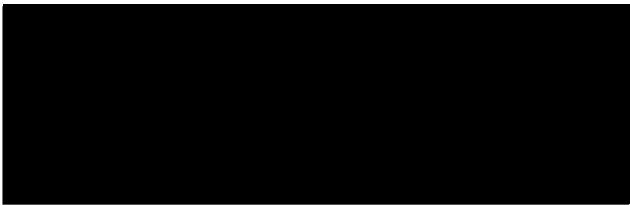
I called the National Highway Traffic Safety Administration and filed a complaint (#10630933) back in Early August.
