The dealer Scranton Motors, inc. (of Vernon) won't replace my purchase, or return my money. Their is no Statute of Limitations on this purchase, because my vehicle was sent out of state. I think I'm being discriminated against because of my "color" and because at the present time, (as a senior-citizen) I can't afford an Attorney. I would like to know why! The Attorney General's Office won't investigate Scranton Motors, inc. and find out why! my purchase (verified by General Motors) was sent out of Connecticut and leased to other "customers" then returned to Connecticut without telling me anything. When I sent paperwork on this sale to General Motors, "customer service", I was told, (on letter from "G.M.") my purchase was for a 2003' Trailblazer. This is how I found out Scranton Motors, Inc. did a "Bait & Switch" on me, on Saturday Sept. 21<sup>st</sup> 2002', when the vehicle shocked me, I returned it on Monday, (dealership closed on Sunday) Sept. 23<sup>rd</sup> 2002' told "salesman" I had a bad heart, this truck "shocked the heck out of me, I wanted my deposit back" I was told quite "you purchased the truck" 3" times, with your initials, I'm Sorry, there's nothing I can do.

I never saw the truck I purchased again.

I agree that this is subject to the following terms:

- 1. Trade-In Credit May Change.** If I do not deliver the trade-in vehicle to you when this agreement is signed, I understand that the trade-in credit shown on the front of this agreement may be changed by you. If the trade-in credit is reduced and I am not satisfied, I understand that I can cancel this agreement if the purchased vehicle has not been registered in my name or delivered to me.
- 2. Trade-In: Buyers Obligations.** At the time I deliver the trade-in vehicle to you I agree to give you satisfactory proof that I own the vehicle and to sign a mileage certification statement for the trade-in vehicle. I warrant (guarantee) (a) that there are no liens or encumbrances on the trade-in vehicle except as shown on the face of this agreement; (b) that the trade-in does not have a welded or bent frame and that the motor block is not cracked, welded or repaired; (c) that the vehicle has not been flood damaged or declared a total loss for insurance purposes; and (d) that the emission controls have not been removed or tampered with.
