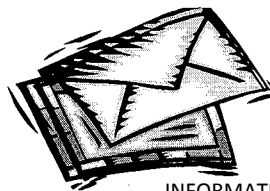

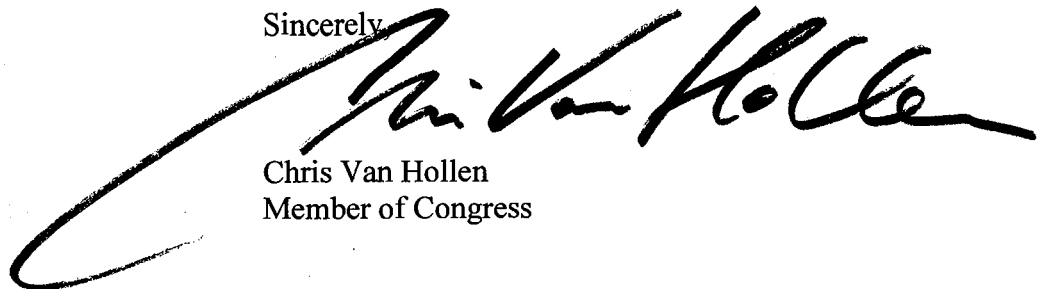

Recently, there have been a number of stories in the media about defective airbags in Honda automobiles. I accessed the recommended website and I discovered that the 2005 Honda CR-V that we own was on the recall list. I was very concerned because this vehicle is the one that my daughter drives.

I called the U.S. headquarters of Honda and I was told that the recall was VIN specific and that our VIN was not on the recall list. I then called the local Honda dealer here in Westminster and I was told the same thing.

I don't see how this is possible. I understand that one supplier, Tanaka, supplies all of the airbags for Honda. So how can they possibly know that the airbag for one vehicle is okay but the airbag for another vehicle is defective?

Please make a formal request to the Department of Transportation and ask why my vehicle was not included in the recall.

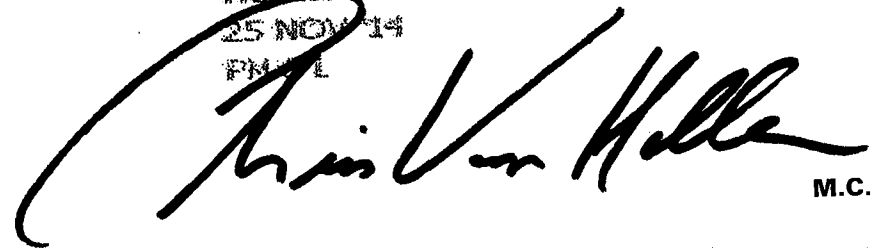
