On 1/26/15 I rec'd notice from Toyota for safety recall on my front passenger airbag inflator that was not previously replaced & that replacement is required. Also, that I should not operate the vehicle with occupants in the front passenger seat - which is very inconvenient to me. Nothing was done & that's when I called on 3/10/15 & given # 10693284.

On 3/28/15 I rec'd another notice stating that my vehicle previously had only the sub-wire harness installed & the SRS ECU was not replaced & is now also required for this Safety Recall. To date nothing has been done.

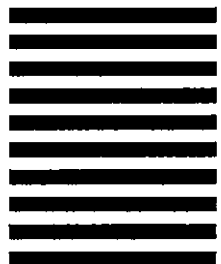

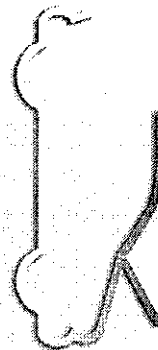
