Fuel Filler neck leaks at gas tank, CAN only fill gas tank 1/2 way before it starts to leak out. This has gone on for several years.
There are recalls already in action for cobalts and other STAIN ions. The recall needs to be extended to 2005 SATURN ions, for this gas tank recall.
We have already been issued recalls on ignition + power steering pumps and had those fixed.
