The insurance company Nationwide has possession of car.

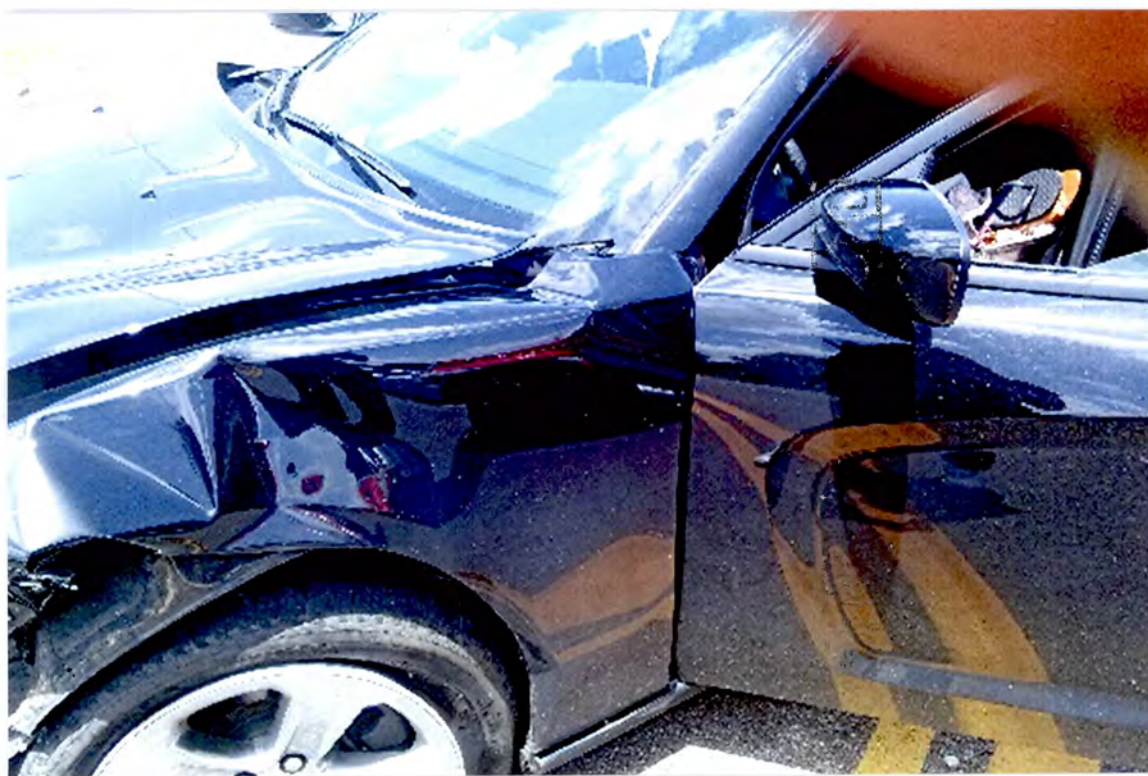
