The dealer, where I took my Van for repair, informed me that the Mfg. was only sending one part at a time and if had to be installed and documented back to the Mfg. before they could get another part and much time of idleness goes by because they don't have the parts. There were about 40 in front of me and I have now been waiting 2 months. If the mfg. would send parts this issue could be solved.
