I have enclosed a website link showing numerous complaints about this safety problem. COMPLAINTS REGARDING FIAT Trunk Latch

It appears that you have known about this problem and did not make it a recall. However, you changed the entire assembly in future vehicles making a repair extremely costly- not to mention a safety concern!

I would appreciate your prompt concern over safety and responsibility of making this issue a Recall and reimbursing me for a new lift gate assembly and gate latch and release assembly. My invoice for \$686.05 is enclosed.
