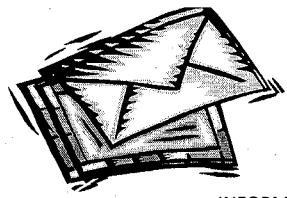

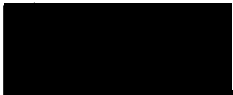

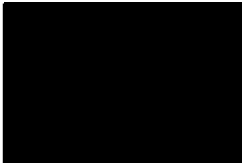
Dear Congressman Wittman:

Yesterday I received a recall notification letter from The Lincoln Motor Company, dated July 2016, on our 2007 Lincoln MkZ. It notified me that the vehicle's "...passenger frontal airbag inflator may rupture in the event of a crash necessitating airbag deployment".

Sir, I want to know why this notification has taken so long, and has apparently been withheld by the Federal Government and Lincoln.

I have checked the Takata recall websites in the past and this vehicle, nor any Lincoln, was included. Indeed, the government website even this morning does not include Lincoln. So again, why has this information been withheld?
