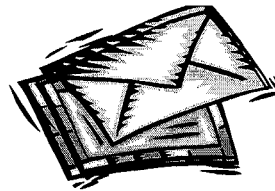

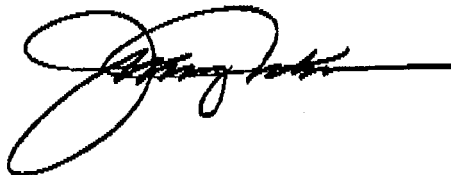

Takata We had a 2013 VW Passat, which had defective airbags. There has no resolution for this and we were afraid of the hazards. We traded the car, but had to take a \$3,000 loss. The U.S. government hit Takata with \$70M in penalties plus \$130M in safety measures. We would like \$3,000 of that money for our loss.

The car dealership had to sell car at auction

and advised us this was due to the airbags, so they would give us the \$11,000. Other dealerships told us the same.
