Description: On August 10th or 11th, 2016, in the evening about 8:00pm I was driving my Dodge Avenger-2013- while I was driving my car my sandal shoe came off my right foot while I was at the stop light. I was feeling for my shoe to put it back on, as I was feeling for it my right foot hit an opening of metal right above the break pedal and accelerator. My foot began to bleed profusely. On August 14th I went to the Emergency room at DePaul Hospital due to pain and swelling of my right foot. I had to have a tetanus immunization, x-ray, prescribed antibiotics and pain medication. On August 17th I filed a complaint with Dodge cooperate office in regard to the incident. I was told to contact the dealership. I made an appointment with the dealership, at that time they wouldn't provide me with a rental car, because they said it wasn't in the case notes to give me a rental. They offered me a rental on my own expense. I declined this due to this incident was due to negligence of Chrysler-Dodge-Jeep when the car was made and inspected. I purchased my car in June or July of 2013 new. I have been riding around in my car for three years in danger. I contacted cooperate again and talked to Caitlin (800-992-1997), explained the situation with her and this is when an inspector Chuck (815-252-9820) called about setting an appointment at the dealership to inspect the car. I had to leave work early to get the car inspected by Chuck on 08-30-2016 at 1:00pm. He inspected the car took pictures and I sent him pictures. He sent in the report and after that. I received a letter on 09-26-16 in regard to the outcome. Letter is attached with pictures, etc.
On September 12, 2016 @ 4:00 I had a follow-up appointment with my medical Doctor-I had to call off of work from my part-time job to make this appointment.
