My statement that I gave over the telephone is not accurate on the attachment. Nothing in the report is what I gave over the telephone. Below is what I gave over the telephone. I am surprised to read the attached statement, as this is not my testimonial. The person who I spoke with over the telephone, did she confuse me with someone else who gave their complaint? I have waited for quite sometime to post my complaint and later to find out that the attach report is not accurate and needs to be corrected ASAP.

THIS IS MYTESTIMONIAL I GAVE TO THE NHTSA LADY OVER THE TELEPHONE: I am the owner of a 2003 Nissan Altima- On 2/18/17 I drove my vehicle to a car wash in Linden, NJ. After my vehicle was washed, I was instructed by the car wash employee to stay on my left side, as there was a vehicle on the right side and I had my foot on the Brakes (D) and immediately my vehicle jolted twice and immediately unintended accelerated at a high speed while I still had my foot on the Brakes. Smoke started to come out and the Air Bag came out before the crash. I had to control the steering wheel not to hurt anyone as there were several parked vehicles and people vacuuming/cleaning out their vehicles. According to the Police Accident Report, there were 7 parked vehicles that I hit. I was injured and the police and ambulance arrived. I was in shock and crying and told the police officer that my vehicle unintended accelerated at a high speed while I had my foot on the Brakes. There was no time for me to even park the vehicle. Everything happened immediately after the car wash. I ask the police officer were there any recalls on my vehicle that I was not notified. I repeatedly told the other officer the same thing that my vehicle would not stop. I had my foot on the Brakes and unintended accelerated at a high speed with no warning indicator lights. The Ambulance took me to Rahway Hospital, NJ. My injuries were my swollen ankles especially on my right foot, that is because I would not let go on my Brakes and the vehicle just kept accelerating, swollen/bruised knees, head, neck, shoulders and back.

The attached report is not accurate at all and needs to be corrected ASAP. Attached is the police report diagram of the parked vehicles I hit. Also attached/BELOW is my damaged vehicle. My vehicle was totaled. I am hoping that my complaint is completed for others to read and my family as well.

Driver of V1 was issued MV Summons [REDACTED] for [REDACTED] Careless Driving.

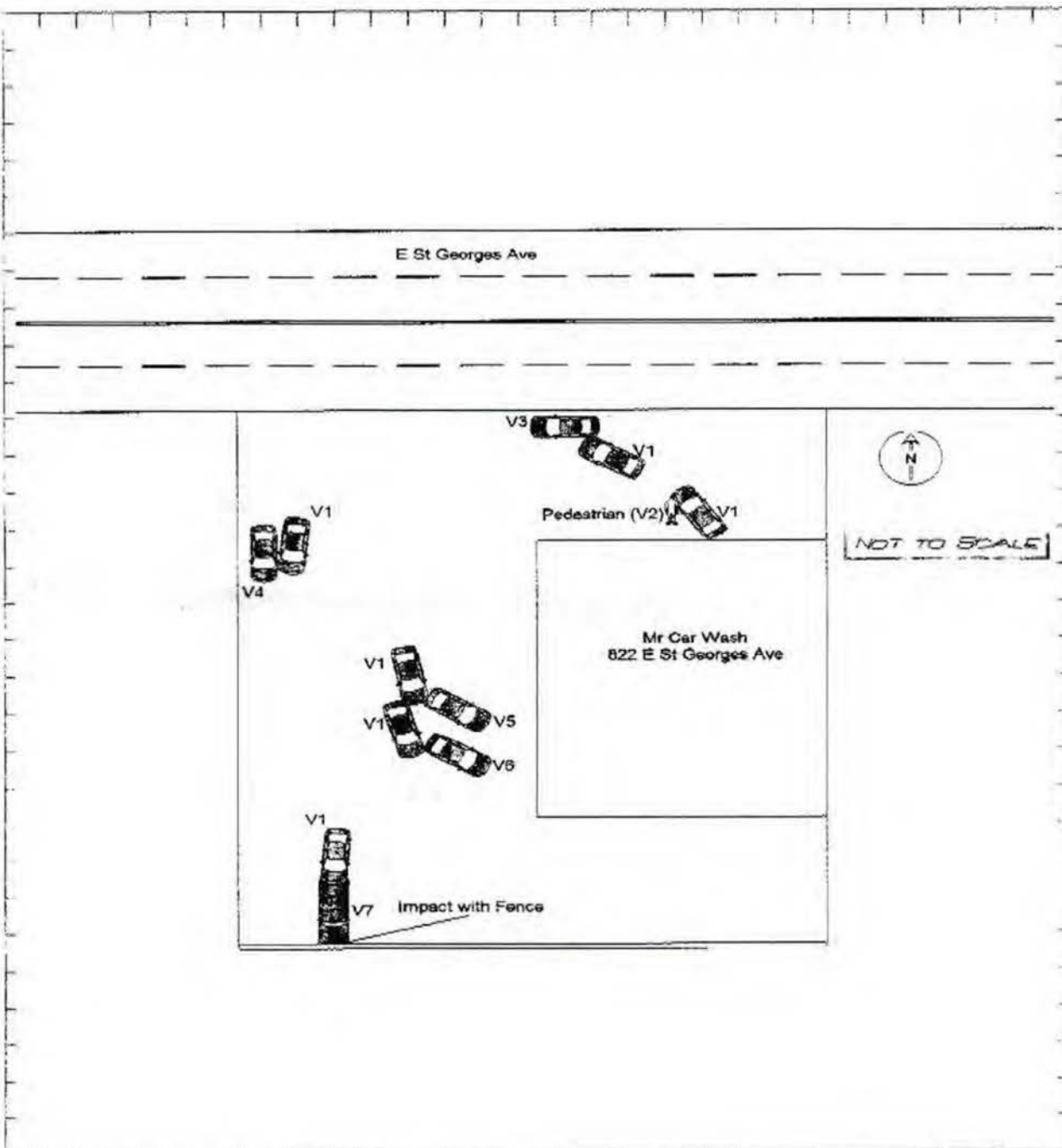
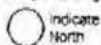
