SECTION 1 - OVERVIEW

This Customer Agreement ("Agreement") is between the Agreement Holder identified above (hereafter referred to as "You" and/or "Your") and Toyota Motor Insurance Services, Inc. (hereafter referred to as "Agreement Administrator", "We", "Our" and/or "Us"). This Agreement entitles You to receive the factory recommended services referenced in Your Warranty and Services Guide for normal driving conditions and specific to the year and model of the vehicle identified above as Your Vehicle (hereafter referred to as "Covered Services"). Your Vehicle includes certain maintenance services provided by the manufacturer as part of the purchase price of Your Vehicle. Those services are not covered under this Agreement. All Covered Services provided are subject to the terms, limitations and conditions set forth in this Agreement. This Agreement also entitles You to receive roadside assistance, an added benefit which is provided by Cross Country Automotive Services, Inc. This Agreement is not an insurance policy, a warranty, or a guarantee.

SECTION 2 - CONTRACT PERIOD

Covered Services under this Agreement will begin with the next interval following expiration of the manufacturer provided maintenance program. This Agreement terminates on the earlier of (i) the Agreement Expiration Date shown above or (ii) the cancellation of this Agreement in accordance with the cancellation provision of this Agreement.

If You do not have the Covered Services performed, You will not be entitled to any refund after this Agreement terminates. Covered Services must be performed within one year of the Agreement Expiration Date.

SECTION 3 - CONTRACT COVERAGE AND LIMITATIONS

- All the Service Intervals set forth above, Your Selling Dealer will provide Your Vehicle with the Covered Services. You must be the legal owner or lessee of Your Vehicle at the time the Covered Services are provided, except as provided in Section 6.
- You are not entitled to receive additional Covered Services once all Covered Services for this Agreement have been used.
- Additional services may be recommended by the manufacturer of Your Vehicle. These services are not covered by Your Agreement and are Your responsibility.
- All Covered Services must be performed within one year of the Agreement Expiration Date.
- Services or repairs which may be recommended by the dealer servicing Your Vehicle or are revealed by a Covered Services inspection are Your responsibility and must be paid for separately. Covered Services will be provided by Your Selling Dealer during normal business hours. Transportation of Your Vehicle to or from the dealership is not covered.
- No Covered Services will be provided if Your Vehicle's odometer has been altered, disconnected or is inoperable, or if the actual mileage of Your Vehicle cannot be documented.

SECTION 4 - YOUR RESPONSIBILITIES

- To receive Covered Services You should contact the service department of Your Selling Dealer to schedule an appointment for the performance of Covered Services, and take Your Vehicle to the service department as scheduled. The dealer will not provide the services in any location other than in the dealer's service department.

SECTION 5 - SHOULD YOU NEED CUSTOMER ASSISTANCE

There is no charge for the first reissuance of an Agreement; thereafter a \$25.00 reissuance fee will be applied.
- Should You be unable to return to Your Selling Dealer for service, please contact Us at the Toll Free number listed in Section 5a above for a participating dealer.

SECTION 6 - TRANSFERRING THIS AGREEMENT

- This Agreement is transferable only if it has not been previously transferred and, if a lienholder is shown above, the retail installment contract or lease has been paid off. It is not transferable to another vehicle.
- If this Agreement is transferable, as described above, and if You sell or make a gift of Your Vehicle and wish to transfer this Agreement to the new owner of Your Vehicle, You must submit a written transfer request to Us within 15 days of the change of ownership. To request a transfer, draw a line through Your name as shown at the beginning of the Agreement, fill in the name and address of

SECTION 7 - CANCELLATION

A. Our Rights to Cancel This Agreement

We have the right to cancel this Agreement for any act of fraud or material breach of the terms and/or conditions of the Agreement by giving You ten (10) days written notice and specifying the reason for cancellation. If any refund is owed, We will pay a pro rata refund of the Agreement Purchase Price, within thirty (30) days of the cancellation date, based on percentage of time elapsed from the Agreement Application Date.

B. Your Rights to Cancel This Agreement

You have the right to cancel this Agreement at any time and to request a refund. You may cancel this Agreement by returning this Agreement to Your Selling Dealer. If You cannot or do not wish to return to Your Selling Dealer, send this Agreement with Your written request to cancel, including the date of cancellation and Your vehicle's current mileage, to the address given in Section 5a. If You financed Your Vehicle and have paid off the retail installment contract or lease, also provide a Release of Lien issued by the creditor or lessor with Your cancellation request. If We have notice of a lienholder or lessor and Release of Lien is not provided, any refund will be issued jointly to You and the lienholder/lessor or, at Our discretion, directly to the lienholder/lessor.

C. Payment of Refund

- For Agreements purchased prior to the expiration of the manufacturer's maintenance program:
 - If this Agreement is cancelled prior to the expiration of the manufacturer's maintenance program or within the first thirty (30) days after the expiration of the manufacturer's maintenance program, and if no Covered Services have been provided, We will refund the Agreement Purchase Price. If Covered Services have been provided, We will provide a pro rata refund of the Agreement Purchase Price based on the percentage of time elapsed from the expiration of the manufacturer's maintenance program or the percentage of Covered Services that have been performed (whichever percentage is greater).
 - If this Agreement is cancelled thirty-one (31) days or more after the expiration of the manufacturer's maintenance program, We will provide a pro rata refund of the Agreement Purchase Price based on the percentage of time elapsed from the expiration of the manufacturer's maintenance program or the percentage of Covered Services that have been performed (whichever percentage is greater), minus a \$25.00 processing fee. All such refunds will be computed based upon the cancellation date.
- For Agreements purchased after the expiration of the manufacturer's maintenance program:
 - If this Agreement is cancelled within thirty (30) days from the Agreement Purchase Date, and if no Covered Services have been provided, We will refund the Agreement Purchase Price. If Covered Services have been provided, We will provide a pro rata refund of the Agreement Purchase Price based on the percentage of time elapsed from the Agreement Purchase Date or the percentage of Covered Services that have been performed (whichever percentage is greater).
 - If this Agreement is cancelled thirty-one (31) days or more from the Agreement Purchase Date, We will provide a pro rata refund of the Agreement Purchase Price based on the percentage of time elapsed from the Agreement Purchase Date or the percentage of Covered Services that have been performed (whichever percentage is greater), minus a \$25.00 processing fee. All such refunds will be computed based upon the cancellation date.

SECTION 8 - GENERAL CONDITIONS

- No amendment or modification of this Agreement is binding unless it is in writing signed by Our duly authorized representative.
- This Agreement is the complete agreement between You and Us. No verbal representations relating to the terms, conditions or interpretation of the Agreement should be relied upon by You.

1. EITHER YOU OR WE MAY CHOOSE TO HAVE ANY DISPUTE BETWEEN US DECIDED BY ARBITRATION AND NOT IN COURT OR BY JURY TRIAL.
2. IF A DISPUTE IS ARBITRATED, YOU WILL GIVE UP YOUR RIGHT TO PARTICIPATE AS A CLASS REPRESENTATIVE OR CLASS MEMBER ON ANY CLASS CLAIM YOU MAY HAVE AGAINST US INCLUDING ANY RIGHT TO CLASS ARBITRATION OR ANY CONSOLIDATION OF INDIVIDUAL ARBITRATIONS.
3. DISCOVERY AND RIGHTS TO APPEAL IN ARBITRATION ARE GENERALLY MORE LIMITED THAN IN A LAWSUIT, AND OTHER RIGHTS THAT YOU AND WE WOULD HAVE IN COURT MAY NOT BE AVAILABLE IN ARBITRATION.

Any claim or dispute, whether in contract, tort, statute or otherwise (including the interpretation and scope of this Arbitration Provision, and the arbitrability of the claim or dispute), between you and us or our employees, agents, successors or assigns, which arises out of or relates to your credit application, purchase or condition of this vehicle, this contract or any resulting transaction or relationship (including any such relationship with third parties who do not sign this contract) shall, at your or our election, be resolved by neutral, binding arbitration and not by a court action. If federal law provides that a claim or dispute is not subject to binding arbitration, this Arbitration Provision shall not apply to such claim or dispute. Any claim or dispute is to be arbitrated by a single arbitrator on an individual basis and not as a class action. You expressly waive any right you may have to arbitrate a class action. You may choose the American Arbitration Association, 1633 Broadway, 10th Floor, New York, New York 10019 (www.adr.org), or any other organization to conduct the arbitration subject to our approval. You may get a copy of the rules of an arbitration organization by contacting the organization or visiting its website.

Arbitrators shall be attorneys or retired judges and shall be selected pursuant to the applicable rules. The arbitrator shall apply governing substantive law and the applicable statute of limitations. The arbitration hearing shall be conducted in the federal district in which you reside unless the Seller-Creditor is a party to the claim or dispute, in which case the hearing will be held in the federal district where this contract was executed. We will pay your filing, arbitration organization require us to pay more. The amount we pay may be reimbursed in whole or in part by decision of the arbitrator if the arbitrator finds that any of your claims is frivolous under applicable law. Each party shall be responsible for its own attorney, expert and other fees, unless awarded by the arbitrator under applicable law. If the chosen arbitration organization's rules conflict with this Arbitration Provision, then the provisions of this Arbitration Provision shall control. Any arbitration under this Arbitration Provision shall be governed by the Federal Arbitration Act (9 U.S.C. § 1 et. seq.) and not by any state law concerning arbitration. Any award by the arbitrator shall be in writing and will be final and binding on all parties, subject to any limited right to appeal under the Federal Arbitration Act.

You and we retain the right to seek remedies in small claims court for disputes or claims within that court's jurisdiction, unless such action is transferred, removed or appealed to a different court. Neither you nor we waive the right to arbitrate by using self-help remedies, such as repossession, or by filing an action to recover the vehicle, to recover a deficiency balance, or for individual injunctive relief. Any court having jurisdiction may enter judgment on the arbitrator's award. This Arbitration Provision shall survive any termination, payoff or transfer of this contract. If any part of this Arbitration Provision, other than waivers of class action rights, is deemed or found to be unenforceable for any reason, the remainder shall remain enforceable. If a waiver of class action rights is deemed or found to be unenforceable for any reason in a case in which class action allegations have been made, the remainder of this Arbitration Provision shall be unenforceable.

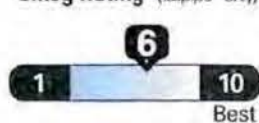
