1. THE 2016 KIA SOUL WAS PURCHASED IN GREER, SC 11/28/2016 IN GREER, SC BY [REDACTED] [REDACTED] (THEN WAS MY BOYFRIEND AND WE LIVED TOGETHER IN CLEMSON, SC [REDACTED] [REDACTED] CLEMSON, SC [REDACTED] ----->>
2. DUE TO PREVIOUS CYBER SECURITY ISSUES WITH FORMER VEHICLES I PURCHASED A CREDIT REPORT FROM A IDENTITY THEFT CYBERSECURITY CREDIT REPORT AGENCY AND THE SAME DAY THE CAR WAS PURCHASED I RECEIVED MUNICIPALITY ALERTS UNDER MY NAME AND SOCIAL SECURITY NUMBER AND A TRUE NAME FRAUD ALERT ON THE SAME DAY THE VEHICLE WAS PURCHASED. I KNEW THEN, THE VEHICLE WAS GOING TO HAVE SOME ISSUES BEING MY NAME WAS NO WHERE LISTED ON THE CONTRACT.
3. I ASKED TO SEE THE CONTRACT AND THE FOLLOWING THINGS I NOTICED THAT WASN'T CORRECT: THE COLOR WAS SHOWING TITANIUM GRAY, BUT THE CAR IS BLACK, THE BODY STYLE WAS DIFFERENT IN 3 LOCATIONS ON THE CONTRACT; ! A6 4DR Hatchba, WAGON, STATION WAGON INCLUDING VAN AND TRUCK, THE ADDRESS LISTED WAS [REDACTED] CLEMSON SC (BF MOTHER'S AND BROTHER'S ADDRESS NOT HIS), THE ODOMETER SHOWED 10263 BUT I WAS [REDACTED] AND ONLY ONE OWNER HAD THE CAR PRIOR TO ME BUT WHEN SEARCHING ONLINE THE VIN NUMBER CAME BACK AS: SALVAGE-----
[REDACTED] AND CAME BACK THE COLOR BLUE--- [REDACTED] [REDACTED] SHOWS GRAY HERE [REDACTED]
4. THE DEAL NUMBER ON CONTRACT READS: 58139 AND CUSTOMER NUMBER IS [REDACTED] ON FORM 400. THE LIEN HOLDER IS SUNTRUST IN WILMINGTON, OHIO ON THE CONTRACT BUT STATE FARM HAS SUNTRUST IN ANOTHER STATE.
5. KEEP IN MIND I WAS TRYING TO GETH THE 2016 HYUNDAI SONATA IT WAS WHITE AND THEY LET ME DRIVE THE VEHICLE WITH A DEALER TAG UNTIL MY CREDIT REPORT WAS UNLOCKED AND THEY RECEIVED MY REPORT BUT IT NEVER DID DUE TO IMPERSONATION AND SOMEONE GETTING A HOLD TO MY DL, SSN, TAX RECORDS, AND SECURITY KEY(STEALING IT). I USED THE INSURANCE I ALREADY HAD ON THE 2005 BURGUNDY MONTEGO I PURCHASED FROM SPARTANBURG UPSTATE AUTO AUCTION (LEMON). [REDACTED] PURCHASED MY INSURANCE FROM LEON HIXS IN SPARTANBURG SC FULL COVERAGE SO I SWAPPED THE INSURANCE OUT FOR THE MERCURY FOR THE HYDUNDAI. BEFORE THE PROOF OF INSURANCE WAS STOLEN ABOUT A WEEK AGO; IT SHOWED THE LIEN HOLDER AS WESTLAKE FINANCIAL WHICH IS ON MY CREDIT REPORT WHEN IT SHOULD HAVE BEEN KIA OF GREER OR MCE CARS, INC DBA KIA OF GREER ON 14345 E WADE HAMPTON BLVD GREER, SC. IT SHOWED MY COUSIN'S [REDACTED] RIVERS LICENSE NUMBER ALONE WITH MY AS THE DRIVER WHEN SHE WAS SHOULDN'T HAVE BEEN AND ALSO ENDORSEMENTS, AND NEW BUSINESS VEHICLE WHEN THAT WAS FRAUD.
6. WHEN THAT WEEK WAS UP I RETURNED THE SONATA TO KIA AND [REDACTED] PURCHASED THE KIA I HAVE NOW...OR I DRIVE. THE IRONIC THING IS NOW MY COUSIN [REDACTED] NOT EVEN 2 WEEKS

LATER HAS THE SAME YEAR, MAKE, MODEL, COLOR VEHICLE THAT ORIGINALLY WAS TRYING TO GET.

7. WE TRADED THE 2005 MERCURY MONTEGO FOR THE KIA SOUL (TOWED TO THEM DUE TO IT NOT STARTING). ON THE KIA CONTRACT IT SHOWS SCDMV TITLE AND REGISTRATION IMF/NON-RESIDENT SALE.(FRAUD)
8. THE VIN NUMBER FOR THE 2005 MERCURY MONTEGO IS IMEFM43105G [REDACTED]; ON THE KIA ITEMIZED CONTRACT FORM IT SHOWS THERE IS SALES TAX ON THE VEHICLE FOR IMF AND THE STOCK NUMBER IS [REDACTED] IT ALSO, SHOWS ON CONTRACT ON THE MERCURY THERE WAS GOVERNMENT CERTIFICATE OF TITLE FEES, INFRACTRUTURE MAINTENANCE FEES, FEES FOR FIDELITY FOR FWS SVC CONTRACT, TO FIDELTY FOR MAINT PLAN FEES ADDED TO MERCURY (STRANGE) BEING THE KIA WAS BEING PURCHASED NOT THE MERCURY. I ASSUME THE INFORMATION ASSOICATED WITH THE MERCURY CONVERTED TO THE KIA BEING IT WAS TRADED?

ON MAY 31, 2019 THIS DAY I WENT IN TO SEE WHY I WAS ON THE POLICY IF IM NOT ON THE CONTRACT AND DIDN'T CONSENT TO BEING ON THE POLICY, AND TO BE REMOVED.
13. ON THE VEHICLE SUMMARY IT SHOWS: SFPP# [REDACTED] ON THE REVISED REQUEST I, [REDACTED] AKA [REDACTED] ASKED TO BE REMOVED BUT IT SHOWS: [REDACTED] BEING REMOVED. BUT UNDER REMARKS IT SAIDS REMOVE MY NAME. ALSO, WHEN LOGGING INTO THEIR APP MY MOTHER'S PHONE NUMBER (FORMER NUMBER [REDACTED] [REDACTED]) THAT IS ON THE FRAUDULENT ALLSTATE POLICY WAS LISTED UNDER MY NAME AND A BREACHED EMAIL ADDRESS. (FRAUD). WHEN RESEARCHING THE VIN ON NUMEROUS OCCASIONS I TYPED THE VIN IN BUT THEN THE VIN IS REPLACED WITH THE FOLLOWING VIN NUMBER'S ON ALL SEARCHES: WHEN RESEARCHING THE VIN ON NUMEROUS OCCASIONS I TYPED THE VIN IN BUT THEN THE VIN IS REPLACED WITH THE FOLLOWING VIN NUMBER'S ON ALL SEARCHES: KNDJP3A52G7 [REDACTED] KNDJP3A52G7 [REDACTED]
16. THINGS I NOTICED THAT LOOKED AS OF THE VEHICLE WAS BEING TAMPERED WITH: THE SEAT LATCHES WOULD BE LOOSE THE NEXT MORNING AFTER FASTENING THEM THE NIGHT BEFORE,

AFTER CLEANING THE VEHICLE THE NIGHT BEFORE I WOULD FIND DIRT ON CARPET, FINGERPRINTS ON VEHICLE, SCREW(S) IN THE FLOOR THE NEXT MORNING, THE BOTTOM COVER OF THE KIA WAS CUT OUT BEHIND THE TIRES-IN FRONT OF THE HEADLIGHTS, THE RADIO WILL ONLY WORK IN CERTAIN LOCATION (SIGNAL WEAK UNTIL CLOSE BY CERTAIN AREAS); THE AREAS IS WHEN I BECOME LIGHT HEADED, CAN'T FEEL MY DRIVER FOOT (IT GOES TO SLEEP), THE SEATBELT DINGS WHEN NOT ON IN CERTAIN AREAS, WIRING HANGING OUT THE ROOF OF VEHICLE, KIA OF ANDERSON TOLD US DUE TO THE AFTERMARKET WIRING BY THE FUSES THEY COULDN'T FIX IT DUE TO KIA NOT PUTTING IT THERE, WHEN RUNNING A DIAGNOSTIC ON VEHICLE (W/O CHECK ENGINE LIGHT ON) KIA HAS FOUND PROBLEMS WITH VEHICLES, AND OTHER'S (ADVANCE, AUTO ZONE)—SO THE LIGHT ISN'T COMING ON BUT THE ISSUES STILL ARE OCCURRING, WE'VE NOTICED DIFFERENT COLOR BLACK INTERIOR PARTS WHEN THEY ALL WERE THE SAME, WHEN A/C OR HEAT IS ON MY KIDS NOSE'S BLEED, CERTAIN FUSES WON'T GO IN ANYMORE, A MOBI BOX INSTALLED BEHIND THE STEERING WHEEL, A BOX BEHIND THE RADIO NEAR THE DASH IS INSTALLED, WHEN COMING CLOSE TO MY SISTER VEHICLE- [REDACTED] MY STEERING WHEEL LOCKS UP, WHEN GETTING CLOSE BY MY BROTHER'S HOUSE ON MEREDITH CIRCLE MY RADIO CUTS OFF AND THEN, ON AND A HELECOPTER (ALWAYS) FLYS ON 100% OF THE TIME AND WHEN I HAVE A PHONE THE DEPT OF HOMELAND SECURITY WEBSITE WILL POP UP ON THE GOOGLE CHROME, [REDACTED] AND [REDACTED] WHEN NEAR MY MOTHER'S HOME THE SAME EXACT THING WILL HAPPEN EXCEPT A COUPLE OF TIMES: MY PHONE NEVER TURNED BACK ON UNTIL I WAS OUT OF SPARTANBURG COUNTY([REDACTED] [REDACTED] [REDACTED] SPARTANBURG SC), SOMETIMES MY MOTHER WOULD ASK ME WHERE I WAS AT AND I WOULDN'T TELL HER AND THEN A FEW SECONDS LATER MY RADIO CUTS ON THEN OFF- AND THEN SHE SARCASTICLY ANSWERS HER OWN QUESTION AS IF I ANSWERED.

17. OTHER THINGS I FIND LIFE THREATING, STRANGE, UNFAIR, UNJUST; IS THE UNITED STATES OF AMERICA BUT A [REDACTED] YEAR OLD CHILD AND A [REDACTED] YEAR OLD CHILD (MINE) IN HARMS WAY BY NOT INSPECTING THE VEHICLE PROPERLY; WHEN I'VE BEEN FILING COMPLAINTS THE LAST 3 YEARS AND HAVE BEEN COMPLETELY EITHER: BEEN IGNORED, MAIL BEING INTERCEPTED (THEFT), PHONES, LAPTOPS, EVIDENCE IS BEING STOLEN AND ALTERED, OR SUSPECTS BEAT ME TO THE PUNCH BEING THEY HAVE ALL MY INFORMATION. WHEN I'M DRIVING I NOTICED THE VEHICLE SPEEDS AND SWITCHES GEARS BY IT SELF NESR 18 WHEELER TRUCKS, THE CENTER OF HEAD BEGINS TO BURN, THE WHEELS BEGIN TO WOUBLE LIKE THEY ARE ABOUT TO FALL OFF NEAR 18 WHEELERS, MY LEFT ARM WHILE RESTING IT ON THE DOOR; DRIVING IT BECOMES SWOLE AND IN PAIN, WHEN MY FOOT HITS THE GAS PEDAL MY RIGHT LEG

COMPARTMENT BECOMES IN PAIN, HURTS, STINGS AND THEN, FALLS ASLEEP. I SMOKE AND MY HEART AND CHEST NEVER HURTS UNTIL THE A/C OR HEAT IS ON WITH THE WINDOW DOWN IT BEGANS TO HURT BADLY.

CYBERSECURITY ISSUES WITH KIA

1. WHEN GOING TO WELLS FARGO ATM IN THE VEHICLE THE BANK CHARGES ME \$2.00 FOR NON- WELLS FARGO ATM WITHDRAWALS WHEN REALLY IM USING THEIR ATM.
2. WHEN I'M IN SOMEONE ELSE'S VEHICLE IT DOESN'T DO THAT.
3. WHEN GOING TO WALMART, DOLLAR GENERAL, FAMILY DOLLAR, ROSES; MAINLY MY RECEIPTS READ WITH OR WITHOUT DEBIT CARD THE FOLLOWING APPEARS ON RECEIPTS: AN X BY CERTAIN PURCHASES, EFT #, REFERENCE #, AID # (SOMETIMES), TAXED 2 OR 3 DIFFERENT TIMES, TVR#, APPROVAL CODE #, TSI #, ARC#, MODE,TSI #, INV #, ETC.
4. WHEN ENTERING WALMART I'M BEING FOLLOWED AS IF I'M A CRIMINAL, STEAL, HIDING SOMETHING. A FEW TIMES IVE CAME BACK OUTSIDE OF WALMART AND EITHER MY HEADLIGHTS WERE ON WHEN I TURNED THEM OFF, THE LEFT ON PASSENGER SIDE WAS OPENED WHEN ONLY I WAS IN THE CAR DRIVING.
5. WHEN PURCHASING A PHONE FROM WALMART WITHIN TWO DAYS; FORGETTING MY PHONE AT HOME AND BOOKBAG I CAME BACK TO FIND A CRACK ON THE SCREEN AND WHEN TO RETURN IT AND WALMART STATED THE S/N WERE DIFFERENT AND I COULDN'T RETURN IT WHEN MY BANK STATEMENTS PROVIDED PROOF OF PURCHASE. WHEN LOOKING AT BANK STATEMENT I SEEN THAT WHOM EVER SWAPPED THE PHONE USED A CARD ENDING IN [REDACTED] (NEVER HAD) AND I MADE THE PURCHASE USING CARD ENDING IN [REDACTED]. THIS IS THE SAME CARD AFTER HAVING THE PHONE FOR ONLY ONE DAY STOPPED AT MY MOTHER'S HOUSE THAT EVENING TO ALLOW THE KIDS TO SEE HER AND MY SON WALKED IN THE HOUSE WITH MY DEBIT CARD (HE PICKED IT UP OUT THE PASSENGER SEAT CRAWLING THROUGH THE FRONT DUE TO THE CHILD LOCK ON HIS DOOR AND BEING A HABIT HE HAS), I NOTICED MY SISTER [REDACTED] RUSHING OUT THE HOUSE WITHIN 2 MINUTES AND SPED OFF IN HER VEHICLE; KEEP IN MIND PRIOR TO STOPPING AT MOM'S HOUSE I HAD JUST LEFT OFFICE DEPOT GETTING COPIES OF DOCUMENTATION AND SCANNING THEM TO A FLASH DRIVE. WE LEFT OFFICE DEPOT I USED THE CARD ENDING IN [REDACTED] THEN WENT TO MOM'S HOUSE FOR MY DAUGHTER TO CHARGE MY PHONE, AND FOR THEM TO SEE THEM FOR ABOUT 20 MINUTES BEFORE HEADING BACK TO NC. WHEN LEAVING HER HOUSE AND ENTERING ON HIGHWAY 85 NORTH I ASKED THE KIDS WERE THEY HUNGRY THEY SAID A LITTLE, I ASKED DAUGHTER TO REACH IN MY PURSE TO GET DEBIT CARD OUT AND SHE STATED IT WASN'T THERE. MY SON ADMITTED HE TOOK IT INTO MY MOTHER'S HOUSE, I DIDN'T CALL THEM AT ALL I WAITED TO GO TO THE BANK THE NEXT DAY TO GET A TEMPORARY CARD. WHEN LEAVING THE HOUSE I FORGOT MY PURSE AND BOOKBAG AND WENT BACK TO FIND MY BANK STATEMENTS, RECEIPTS, ETC HAD BEEN SWAPPED OUT AND A DEBIT CARD I NEVER SAW WAS ON THE OTTOMAN IN MY LIVING ROOM. BECOMING IRRITATED, FRUSTRATED, ANNOYED, DEPRESSED I BEGAN TO CRY BECAUSE THE STATEMENTS

SHOWED THE OFFICE DEPOT PURCHASE BEING MADE IN A CARD ENDING IN [REDACTED] WHEN I NEVER HAD THAT CARD, AND ALL THE PURCHASES I HAD THE DAY BEFORE INCLUDING THE PHONE RECEIPT FROM WALMART SHOWED EFT I O LIKE IT WAS AN INTERNATIONAL PURCHASE.

6. BY THE PHONE BEING SWAPPED OUT, AND RECEIPTS CHANGED I WENT TO THE WALMART APP BECAUSE I SCANNED THE PURCHASE THAT NIGHT USING [REDACTED] AND EVEN THAT WAS CHANGED----HOW I KNOW BECAUSE ME AND MY DAUGHTER WROTE DOWN ALL DETAILED INFORMATION ON THE RECEIPTS THAT DAY FROM S/N, TC AND RECEIPT NUMBERS AND THEY ARE DIFFERENT FROM THE ONE LEFT SWAPPED OUT.
7. THE BRAKE PEDAL, GAS PEDAL AND OTHER PARTS UNDER THE ENGINE, SEATS, RADIO HAS A SYMBOL OF A CLOCK THE ARROW POINTS AT 12 AND 6 AND SOME OF MAIL HAS HAD THE SAME SYMBOL AT THE BOTTOM OF IT, MY BANK STATEMENTS NOW ARE SHOWING TRANSACTIONS AT LOCATIONS I WASN'T AT, OR WAS AT 3 DAYS PRIOR TO THE TRANSACTION THAT I DIDN'T MAKE WITH THE WELLS FARGO CARD. EXAMPLE: ONE TRANSACTION SHOWS ME AT WALMART ON 11/22/19 AND I PURCHASED SOMETHING FOR \$22.00, WELL YES I WAS AT WALMART AND YES, I MADE A PURCHASE BUT I NEVER USED THE WELLS FARGO DEBIT CARD AND I WAS THERE ON 11/18/19. WHEN LOOKING AT THE TRANSACTION HISTORY YOU WILL SEE DAYS MISSING THAT I USED THE CARD I RECEIVED—YOU DON'T SEE THE DAYS IN A 3 DAY TIMEFRAME PERIOD.
8. MY RADIO IN THE CAR SOME MORNINGS I WAKE UP ITS DATED 3 DAYS AHEAD OR 3 DAYS BEHIND WITH THE WRONG TIME.
9. WHEN SENDING EVIDENCE VIA UPS, USPS, FEDEX THE TIME ON THE RECEIPT SHOWES PACIFIC TIME INSTEAD OF EASTERN STANDARD TIME AND SAIDS POWERED BY: iSHIP ®
10. WHEN ENTERING FAMILY DOLLAR THE CAMERAS FLASH ALERT IN BLOD RED AND SHOWS MY FACE AND EACH ISLE I ENTER THE COME ON AND FLASH WHEN SOMEONE IS ALREADY IN THE ISLE BUT WHEN I ENTER IT POPS ON AND ALERT.
11. WHEN PURCHASING A LAPTOP FROM BEST BUY 4/2019 IN ANDERSON SC WHEN I GOT IN A CERTAIN RADIUS OF [REDACTED] HOME THE BRAND NEW LATOP I JUST BOUGHT AFTER PARKING AND TURNING ON FOR THE FIRST TIME IN THE CAR THE LAPTOP FLASHED 3 TIMES AND TURNED OFF AND NEVER TURNED BACK ON...ASK BEST BUY GEEKS.
12. WHEN GOING ON TO NHSTA AND ENTERED THE VIN FOR THE VEHICLE ALL THE RECALLS ON VEHICLE AND PROBLEMS IM HAVING WITH VEHICLE IS SHOWS UP ON THEIR WEBSITE STATING CONTACT KIA AND WHEN I DO THEY SAY THERE IS NO RECALLS ON MY VIN. I JUST WENT ON THE SITE 12/24/19 AND NOW NOTHING IS SHOWING UP ON MY VIN. IT'S LIKE EVERYTHING I TELL [REDACTED] IS HAPPENING TO THE CAR SOMEONE HEAR'S ME AND ITS LISTED WITHIN A COUPLE WEEKS THE SAME EXACT PROBLEM.
13. WHEN SENDING MAIL VIA USPS IT SHOWS UNCLESAM ETC WHEN I HAVE NO DEBT AT ALL.
14. THE VEHICLE HAS A DUAL OVERHEAD CAMSHAFT (DOHC) WHICH MEANS CAUSING extra pressure, crammING more air-fuel mix into the cylinder -- effectively acting like

1. WIRELESSLY SABOTAGING ME BY TAKING OVER THE BRAKES, TRANSMISSION, STEERING; THROUGH A CELLULAR CONNECTION IN THE RADIO.
2. DEVICES BEING WIRED INTO THE VEHICLE THROUGH A PORT IN REMOTELY.
3. STEALING THE SECOND KEY LINKED TO VEHICLE AND BREAKING INTO IT OVER A CELLULAR NETWORK.
4. CONNECTING MY CAR TO THEIR CAR TO HIDE THEIR ACTIVITY, MASK THEMSELVES. V2V, V2I, V2X METHODS ARE BEING USED.
5. A fleet of AVs communicating with each other as a network of computers in motion; maximizing their impact of the attack to this vehicle.
6. In a recent hack of the financial system, attackers were able to make off with \$81 million (Gopalakrishnan and Mogato, 2016). A single vehicle crash took out a \$60 million fighter jet (Laurendeau and Barbeau, 2006). When attackers gain precise control over even a single moving vehicle, the damages can be quite large.
7. THE AV SYSTEM IS BEING DUPLICATED THE HARDWARE AND SOFTWARE---I SURE OF THIS BEING ALL MAIL IS DUPLICATED, THE WELLS FARGO DEBIT CARDS ARE BEING DUPLICATED BUT MINE IS THE ONE BEING TARGETED AND SHOWS UP AS FOREIGN PURCHASES.
