THE VEHICLE WAS TAKEN TO NISSAN OF HUNTINGTON LOCATED AT 850 E. JERICHO TURNPIKE, HUNTINGTON STATION, NY 11746, TO BE DIAGNOSED. THE CONTACT WAS INFORMED THAT THE DOOR WIRING HARNESS NEEDED TO BE REPLACED. THE VEHICLE WAS NOT REPAIRED. THE MANUFACTURER WAS INFORMED OF THE FAILURE AND A CASE WAS FILED.
