Honorable Deputy Director Owens,

I write you today based off of a communication received from Diode Dynamics about a recall of LED type headlights purchased for my 2018 Buick that replaced the OEM Halogens that were poor at best at night time illumination of the road ahead and thus for us a safety issue.

The letter states 'IMPORTANT SAFETY RECALL 20E-077' although when searching on the NHTSA I was unable to actually find the edict. Thus, from there letter I am interpreting that this is mandatory but no where does this indicate so.

Additionally, I am to understand from my searches of the internet that LED replacements for Halogen equipped vehicles (high and low beams) have not been legal as swap outs. Any LED or HID OEM equipped vehicles would be the only exceptions. Please correct me if I am incorrect in this assertion.

Diode Dynamics further states that "as a remedy" they will replace the LED's they sold me for \$150 (see enclosure) with far less expensive halogen bulbs to replace them with. Oh, and by the way please return the LED's to us to ensure their liability is nil.

Unfortunately, I am not about to comply with their request as I do not feel in any way shape or form this is equitable to me or the other ~28K people who have purchased the product especially since they certified the bulbs as stated on the order; "Bulb Model: SL1 (1630 lumens, Street Legal Output)".

Lastly, if these or any LED replacements for Halogens are not street legal for low and high beam replacement, I would like to know what NHTSA has done to enforce this please? What fines did Diode Dynamics receive from the NHTSA when these were not street legal to begin with or is this so called 'remedy' just a means to get them off any liability? Pompton Lakes, New Jersey



Diode Dynamics has determined that certain SL1 LED replacement headlight bulbs sold by it (Model Numbers DD0215P, DD0216P, DD0217P, DD0218P, DD0219P, DD0323P, and DD0340P) fail to conform with Federal Motor Vehicle Safety (FMVSS) Standard No. 108 "Lamps, Reflective Devices, and Associated Equipment." The bulbs exceed limitations on luminous flux set forth in the standard and may cause increased or excessive glare for oncoming drivers, increasing the risk of a crash.

As a remedy, Diode Dynamics is offering to replace the SL1 LED bulbs with halogen bulbs which comply with the requirements of FMVSS 108, free of charge. To obtain replacement bulbs, please go to: www.diodedynamics.com/recall and fill out the recall form located there. You will be required to provide a receipt or other proof of purchase at the time you submit the form. The form and proof of purchase can be submitted electronically, or you may print the form out and submit the information via mail to the address provided there. 
