Subject: Defective Ram 3500 Trucks

Gentlemen:

We have a fleet of RAM trucks, several of them have problems with the lifters in the engine, numerous issues with the power steering system as well as miscellaneous electrical and fuel pump problems. Seeing as we have a large number of vehicles from RAM, GET would like to seek assistance from a fleet perspective to find a solution with these issues.

We have three specific trucks that have had numerous issues. The three RAM 3500's that we own with VIN # 3C7WRSBJ9JG [REDACTED] 3C7WRSBJ3HG [REDACTED], 3C7WERSBJ7G [REDACTED]. These vehicles started having issues very soon after purchase. All of these vehicles have problems with the lifters. There is a constant hard ticking noise in the engine which we were informed can only be fixed by replacing the lifters or rebuilding the engine. Two of these trucks required the power steering system to be replaced due to metal particulates that were left in the power steering pump from the manufacture. One of the vehicles have had the fuel pimp and fuel pump system replaced at least once. Two of the vehicles had radiator hoses that were not secured properly causing the hosing to come loose. One instance required the radiator to be replaced.

These trucks were custom ordered from the manufacturer for us and thus far we have spent thousands of dollars in repair costs. We were told we could only have a 30,000-mile powertrain warranty by Texan Dodge in Humble, TX. I was just informed by SouthFork Dodge in Manvel-Pearland, TX that due to the fleet nature of our account we should have been covered for 100,000-mile powertrain warranty but have not had the coverage thus far and have had to cover the cost of these repairs out of pocket.

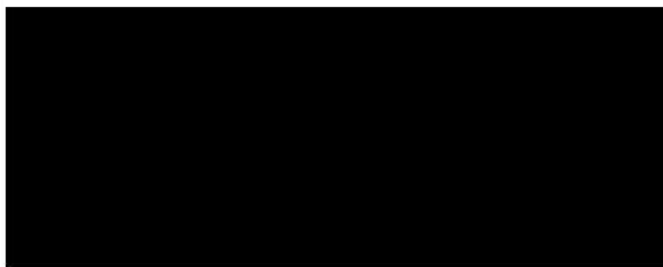
