Thank you for the letter about your model year (MY) 2021 Toyota Corolla vehicle. Your letter was forwarded to the National Highway Traffic Safety Administration's (NHTSA) Office of Defects Investigation. I am pleased to respond.

NHTSA is the Federal agency responsible for improving safety on our Nation's roadways. We are authorized to order manufacturers to recall and repair vehicles or motor vehicle equipment when our investigations indicate that they contain safety defects, such as in their design, construction, or performance. Among other activities, we also monitor the completion rates and adequacy of manufacturers' recall campaigns.

We appreciate the report you provided. Reports from motorists are a very important source of information for us. Unfortunately, you did not include the tire brand name and size for your MY 2021 Toyota Corolla Hybrid vehicle. Tire Rack's website shows the original equipment tire on your vehicle being a Firestone FT140 or Yokohama Avid GT (size 195/65R15). We reviewed our database to identify whether a safety defect trend exists with a tire either rupturing or delaminating without an impact. At this time, NHTSA has not identified sufficient evidence to open a safety defect investigation or to initiate a recall. However, we entered your information into NHTSA's database, where it will be used with other reports to identify any safety defect trends that may require our attention. Your request for a reimbursement does not fall under our jurisdiction. We encourage you to continue to work with Toyota, your dealer, and the tire manufacturer for your vehicle to explore the potential for an amicable resolution to your problem. You may also consider contacting your local Consumer Protection Agency or the Maryland Attorney General's Office regarding your problem and rights under state law. In addition, the Federal Trade Commission (FTC) regulates and investigates warranty and dealership problems, reimbursement matters, and fair-trade practices. Therefore, if you believe this issue potentially relates to such a practice, you may contact the FTC to discuss the matter. There are three ways to contact the FTC: by toll free telephone at 877-382-4357; by mail at Federal Trade Commission, CRC-240, Washington, DC 20580; and by using the Internet complaint form at www.ftccomplaintassistant.gov.

Finally, you may also consider contacting the Better Business Bureau (BBB) Auto Line. The BBB offers free mediation/arbitration to resolve warranty disputes under guidelines established by the FTC. Remedies include repair, reimbursement, repurchase or replacement, depending on program eligibility.
