The contact owns a 2016 Kia Sportage. The contact stated that the check engine warning light was illuminated. The contact received notification of NHTSA Campaign Number: 22V051000 (Service Brakes Hydraulic) however, the part to do the recall repair was not yet available. The local dealer was contacted but vehicle was not diagnosed or repaired. The contact stated that the manufacturer had exceeded a reasonable amount of time for the recall repair. The contact was concerned about a possible vehicle fire. The manufacturer was not made aware of the issue. The failure mileage was approximately 61,000. Parts distribution disconnect.
