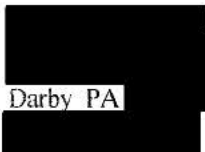

Dear Kia Forte and Forte Koup Owner:

Kia has identified a defect in your vehicle which relates to motor vehicle safety

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Kia Motors has decided that a defect, which relates to motor vehicle safety, exists in certain 2012-2013 MY Forte and Forte Koup vehicles. The defect can result in an engine compartment fire while driving, thus increasing the risk of injury. Our records indicate that you own or lease one of the potentially affected vehicles.

What Is The Problem?

Kia has identified some vehicles that have experienced an engine compartment fire. To date, a cause of such fires due to a manufacturing or design defect has not been identified. Since an engine compartment fire while driving can occur for many different reasons, Kia is conducting this recall to mitigate any unreasonable fire risk due to potential fuel leaking, oil leaking and/or engine damage.

NOTE: Depending on the condition of your vehicle's engine, engine noise, illumination of Malfunction Indicator Light (MIL)  that may be related to an engine mechanical issue, illumination of Engine Oil Pressure Warning Light , fuel smell, burning smell, oil leaking, and/or smoke from the engine compartment can occur. An engine compartment fire increases the risk of injury.

Kia Will Inspect, Test, And If Necessary, Repair or Replace The Engine, At No Cost To You.

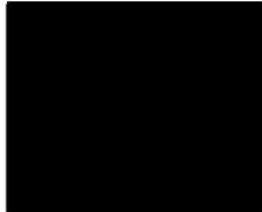
Kia has advised its authorized Kia dealers to conduct an inspection of the engine compartment for any fuel and/or engine oil leaks. Dealers will also perform an engine test, and make any repairs, including engine replacement, if necessary.

In addition, dealers will also perform a Knock Sensor Detection System (KSDS) software update to the engine control unit (ECU) in your vehicle to prevent engine damage due to potential excessive connecting rod bearing wear. Upon completion of the KSDS software update, Kia will warrant any engine long block assembly repairs needed due to connecting rod bearing damage for 15 years/150,000 miles starting from the first date of service, whichever occurs first, for both new and used vehicle owners.

The estimated time required to complete the repair will be 2 to 4 hours, depending on your dealer's schedule. We recommend that you contact your local Kia dealer to schedule a service appointment by phone or online to minimize inconvenience.

What Should You Do?

- If your vehicle displays any of the warning lights listed above, and/or if you notice a fuel smell, a burning/melting odor or smoke coming from the engine compartment, please contact Kia Roadside Assistance at 1-800-333-4542 (4Kia) to request to have your vehicle towed to the closest authorized Kia dealership.
- In the interest of the safety of your passengers, as well as your own safety, please immediately contact your Kia dealership to arrange for the recall repair to be conducted.



For Those With Approval Authority and Responsibility for Righting This Wrong:

Background. This letter is being written to reiterate my request for an engine replacement (at no cost to me), based on the material facts listed below; and also to further highlight the existence of KIA Motors America's latent engine defect. This mechanical/manufacture's latent defect, for which KIA Motors, is acutely aware, impacts the Theta II (GDI), 2.0 liter engine contained within my vehicle. Yet, this latent defect, has and is still continuing to cause engines to catch fire, engines to fail/seize, engines to stop, (while the vehicle is in motion), engines to leak oil (both internally and/or externally) and engines to experience excessive oil consumption issues, etc. The National Highway Transportation Safety Authority, other agencies, as well as numerous internet outlets have been inundated with countless complaints, initiated by KIA vehicle owners/consumers, related to this matter. Despite these well-documented complaints, KIA Motors has neglected to further initiate/expand and/or to fully and completely address this much-needed recall. This matter has been left to exist, without appropriate accountability from the manufacturer. This is a clear safety hazard for the consumers and a definite liability issue for KIA Motors America.

Circumstances of My Car. I am the owner of a 2015 KIA Forte EX. The vehicle has been well maintained and driven minimally, as reflected by my low mileage, and as such, my engine should not be failing. By mileage industry standards, my car has not even "been broken in" yet. In late June 2022, at approximately 61,617 miles, I started having issues with my car. It failed to start intermittently. In addition, occasional intermittent white smoke could be seen coming from the tailpipe, and lastly a sudden and unexplained substantial increase in oil consumption was experienced, (despite my having had a recent oil change 2 months prior on April 13, 2022 at 59,621 miles, my oil level was still critically low). Upon experiencing these mechanical issues, I

replaced the battery (on 6/24/2022), in an attempt to get the vehicle to start. The vehicle started initially, then later failed to start after the battery had been replaced. Upon getting the car started again, I took it to the local KIA dealership for evaluation (on 6/27/2022). The dealership could not immediately explain why the car had failed to start (after a new battery had been installed), and told me that if that happened again, to have the car towed back to the dealership. On 6/27/2022, the dealership did not immediately see a visible external engine leak. They confirmed that the alternator and battery were fine, and suggested that I have an oil consumption test performed to confirm whether excessive oil was being used. The oil consumption test was started on 6/27/2022, and I returned to the dealership for the oil consumption test results on 8/23/2022, after driving the vehicle 1,000 miles, as advised. To my dismay, I was advised that my vehicle had used 3.5 to 4 quarts of oil since the oil consumption test was initiated, approximately 1,000 miles earlier. The dealership also confirmed that this amount of oil was indeed extremely excessive and not in line/range with KIA Motors' normal oil usage standards. I was informed that the car required a new engine, and that a new engine would cost me \$5,950.

Within days, my vehicle started making an abnormal knocking noise, had an intermittent metallic smell, was stalling/misfiring, was extremely sluggish, and had significantly diminished acceleration to the point the car actually stopped, while in motion. In addition, the vehicle was continuing to have excessive oil consumption. I am in receipt of independent expert testimony, regarding my vehicle's engine problem and corroborating the fact that KIA motors has had a longstanding and significant history of being plagued with latent engine defects, resulting in the exact engine issues that I am currently experiencing. The expert also recommended that I return the car to the Kia dealership so that the manufacturer could replace the engine, at no cost to me. Needless to say, my vehicle is not safe to drive on the road and is thus parked. I am disabled and not only rely on my vehicle as personal transportation, but also rely on it for the transportation needs of a relative, with a special needs designation. As you can imagine, being without reliable transportation, due to this latent defect, is not only a substantial inconvenience, but also a health and safety hazard, as doctor appointments have had to be canceled due to transportation challenges. In addition, I must still bear the financial obligation of paying a car note, without the benefit and availability of reliable transportation—which functionally amounts to no transportation, since I clearly am unable to risk my or my family's safety by driving an inoperative vehicle.

Furthermore, this is not a warranty issue. It is a widely-known and substantiated latent/mechanical defect, which KIA Motors needs to correct, without adverse financial impact to the vehicle owners.

During my conversation with KIA's Consumer Relations Department on 8/26/2022 (referenced below), I was advised that an oil consumption issue is an exclusion, under the extended warranty, afforded to KIA vehicle owners, who are impacted by KIA's engine recall and who have complied with the Knock Sensor Update installation (mandated by the recall). As a result, I was advised that "KIA would not be supporting my effort for an engine replacement". To clarify and to reiterate, the excessive oil consumption issue is only one of many engine symptoms that

I am experiencing, which are all well known by KIA and are additionally the direct result of said latent engine defect. This defect causes motor issues/loss of power, engine seizures, knocking noises, vehicle acceleration hesitancy, excessive oil consumption (as a result of internal and/or external engine leaks). Numerous Technical Service Bulletins have been issued, however KIA has only issued (1) recall, and that recall is proving to be very limited in scope, as currently written. An expanded recall is necessary to address the other widespread/well documented engine issues that Kia Forte owners are experiencing. This refusal to correct the problem via an expanded recall, is unethical, potentially deadly, and displays a flagrant lack of integrity, as it relates to your company's practices.

Employee Complaint: Robert at the Irvine Corporate Office. Additionally, I am writing to officially memorialize/file a complaint related to the extremely unprofessional and unpleasant exchange that I experienced during my telephone conversation with Robert from your Corporate Office on 8/26/2022. My call to 1-800-333-4542 was initiated at 4:30 EST/1:30 PST. I was on hold for 2.5+ hours, before Robert answered the phone. Initially his conversation with me was appropriate, but the pleasant communication was short-lived. I stated to Robert that the way he was speaking to me was inappropriate. He replied that he wasn't being rude, but that he was "being stern" with me. As a consumer, it is deplorable that this is the type of customer service that your organization condones. As a customer/client, it is never an acceptable practice for a business entity and/or a representative of said business entity, to speak to a customer in the disrespectful way that I was spoken to. In addition, Robert abruptly hung up on me. Prior to him hanging up on me, I had requested to speak with Robert's superior. He advised me that he was a Corporate Case Manager, and was the final decision maker and condescendingly stated that KIA Motors would not be supporting my effort for an engine replacement, as the extended warranty did not apply to oil consumption issues. **It is clear that the oil consumption issue is not a warranty-related issue, but a latent mechanical/material defect issue, warranting a recall, as are the other mechanical symptoms that I am currently experiencing: (sluggish pick up/sluggish acceleration, intermittent metallic odor, abnormal knocking noise and intermittent white smoke from tailpipe.** I continued to request his superior and reluctantly, he advised me that he would need to transfer me to the voicemail of one of the supervisors and that I would be able to leave a message and that I would receive a return call. Since Robert abruptly hung up on me, this request was not honored. Interestingly enough, YELP has a post by a KIA customer who also references the terrible experience that she had while speaking with Robert at Kia's Corporate Office. YELP also has a post from another KIA customer, who references the same oil consumption issue that I am referencing, and the customer also expresses his dissatisfaction with KIA's lack of accountability for the issue ([reference the posts from \[REDACTED\] and \[REDACTED\] for additional details](#)). A customer should never be spoken to in the manner that I was spoken to by a representative of your company. I have been a loyal/repeat KIA customer/car owner, and it would greatly benefit your organization to understand that both the practice of poor customer service, coupled with the practice of not taking accountability/responsibility for a latent defect in your product, is unacceptable on many levels and reflects poorly upon KIA Motors, as a whole.

Summary of Requested Action:

1. **It is my expectation that I am advised, in writing, of the re-training and disciplinary action, imposed upon Robert by KIA Motors.**
2. **Replace my engine with a new and warrantied engine that doesn't contain any latent/mechanical defects.** I am requesting your favorable response to my request—because this is an egregious latent/mechanical defect, this means that this situation is not a matter for coverage determination, nor warranty consideration. In stark contrast, KIA Motors has a moral obligation to approve and implement a recall related to this matter/my inquiry, coupled with countless others and as a result, to make the necessary latent/mechanical defect repairs and in this case, approve an engine replacement (free of charge to me), as a matter of good faith/principle/integrity and, as a mechanism by which, to diminish the safety hazards for consumers and to diminish the ever-growing liability issues for KIA Motors America, as a whole.
3. **Voluntarily, initiate an expanded recall, inclusive of the excessive oil consumption issue to ensure the safety of all other 2015 KIA Forte EX vehicles.**
4. **Approve payment for me to be provided with reliable/replacement transportation (at no charge), for the entire timeframe that it takes to repair my vehicle.**
5. **Reimbursement for any vehicle depreciation that I experience, as a result of this latent manufacturer's defect.**
6. **Reimburse all out of pocket transportation expenses incurred as a result of this issue.**

Please Note: This letter is also being sent to Mr. Greg Silvestri, VP Service and Aftersale Operations - KIA America, as he has organizational responsibility, as it relates specifically to the following areas within KIA America:

- Aftersale Operations
- Service (specifically Customer Service, and the need for enhanced employee training efforts)
