As i was unable to upload images of this accident, involving my GMC truck and a Tesla MODEL3 DUAL MOTOR, Due to the fact that the MAINFRAME System OF NTHSA wud BOMB out and indicate that there is NO MEMORY, EVEN FOR 1 PICTURE, I AM EMAILING TO
Ensure that nthas and the companies of these vehicles are welcome to do a FULL IMPACT ANALYSIS.
MY truck was damaged, and due to my limited resources, have been able to drive it (as it is also my only personal property).

I only realized that my insurance had lapsed for 35 days, and the insurance company washed their hands away.
I do not have the police report from Alameda county, and no statements have been made by me.
Would be willing to offer my truck for an impact analysis, as long as NTHSA can get the video and recordings from the Tesla, whose insurance is chasing me down, due to my unknowing error of non payment of premium. (Lapsed by 35 days, ALTOUGH I clearly indicated for them to put the payments on autopay)..

I can provide pics of the accident and will ask the county of Alameda to give their report, which i believe has been recorded as me impeding his right of way..which is not the case.

The Tesla swered and at the last minute/seconds..turned to avoid front impact while at the same time the driver was trying to get to take control
Would appreciate your prioritization of 4his case.
