RE: Multiple failures of Ford engines 7.3L V8 350hp, aka "Godzilla engine"

To Whom It May Concern:

We operate a fleet of eleven Ford trucks, model year **2021 or newer**, with the "Godzilla engine" listed above. **Five of those engines had catastrophic failures and had to be replaced over the last 11 months** (see Table 1).

Ford advertised this engine to feature "maximum durability in the harshest environment." However, in reality this engine type is known for its unreliability and early catastrophic failures like the ones we have experienced and documented, according to my conversations with employees of the local Ford dealerships and independent mechanics. How can engines touted to last 300,000 to 400,000 break so early and regularly?

It is our opinion that the frequency and magnitude of these engine failures strongly suggest that **a manufacturer recall is warranted for these engines**. This is the second time that we bring this manufacturer defect to your attention. In fact, **we even asked you for assistance to avoid another catastrophic engine failure in two of vehicles that have failed since** (VINs 1F65FSKNSMO and 1FDWE3FN8MD).

Based on the evidence of manufacturer defects presented in this letter I respectfully request that Ford

1. Refund the actual expenses we incurred to rebuild and replace three of the five engines listed in Table 1.
 - o Requested reimbursement: \$27,900.53 (see Exhibits 1, 3a+b, 5).
2. Refund all reasonable vehicle rental fees we incurred during the repair or replacement of these engines.
3. Investigate the repeated and early failures of this engine.
4. Propose an action plan to avoid failures of this engine in our remaining vehicles listed on Table 2.
