Re: NOTICE of SUA CRASH: 2013 Land Rover, LL4, BLK, FL Tag: FL TQ3XW, Vin: SALAG2D44DA [REDACTED]

To Whom It May Concern:

The purpose of this letter is to place you on NOTICE of a one-car crash on [REDACTED] at - 3:41PM. Florida Highway Patrol investigated the crash. I was the driver. I was not cited by law enforcement. While driving in a parking lot suddenly the car became uncontrollable, and even though I applied the brakes as hard as possible, the car accelerated extremely rapidly until it crashed into an adjacent occupied building. The engine continued to race after the crash until the engine was turned off. The air bags did not inflate. There are witness to these events. When asked if I was injured I said, yes, but I declined medical assistance. I heard the occupant of the building say he had injuries, but he too decline medical assistance.

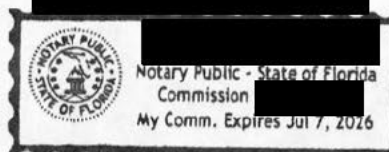
My insurance company, Safeco (Liberty Mutual Claim# [REDACTED]), was notified. Brevard Towing was called to the scene as well as a Building Inspector to see if the car could be pulled out of the building safely. There is property damage to the building. My insurance company tells me my car is deemed a total loss, and will be found so, once it is returned to the insurance company. I engaged Sharpes Body Shop, 7731 Industrial Rd., Melbourne, FL 32904, to do the diagnostics on the car, and authorized Brevard Towing to release the car to Sharpes Body Shop the next day, however, before Sharpes got there the next day, Safeco picked up the car without my authorization. Safeco then towed my car out of county (Orange County) over my previously stated objection. I explained to the Safeco representative that the car was needed for evidentiary purposes and to put an immediate hold on the car until Sharpes Body Shop could pick up the car. Sharpes picked up the car and has done the diagnostics, however, Sharpes says more sophisticated diagnostics are needed to find the cause of the crash. Safeco, again, will make no assurances the car will be held for evidentiary value.

I am attaching a copy of the following: FL Traffic Crash Driver Information Exchange; FHP Vehicle Tow; Certificate of Title, Insurance Card, Registration, and my Driver License.

I do recognize that while 2014 Land Rover is on the recall list, the 2013 Land Rover is not. I send this NOTICE of SUA CRASH for the protection of the public and for further investigation on the Sudden Unintentional Acceleration, failure of the air bags and any the failure of other mechanical issues that would endanger the public.

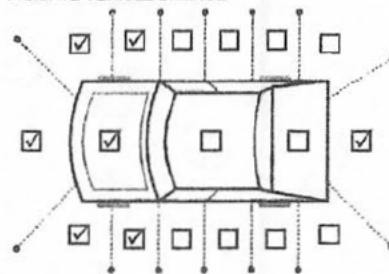
