RE: Criminal Complaint Against Westway Ford Car Dealership of Irving, TX for failure to follow 4 Federal Court Orders of The United States District Court ordering the Automobile Manufacturers to provide 15 Years Manufacturer's Implied Warranty on Automobiles manufactured and sold by Auto Manufacturers in The United States of America.

Greetings.

Please recall my filing a Criminal Complaint with The US NHTSA against Nissan North America, Inc., Nissan MotorsUSA Corporation, their authorized car dealership, Nissan of Lewisville and/or Lewisville Nissan, Lewisville, TX for failure to follow 4 Federal Court Orders of The United States District Court ordering the Automobile Manufacturers to provide 15 Years Manufacturer's Implied Warranty on Automobiles manufactured and sold by Auto Manufacturers in The United States of America on each car manufactured and/or assembled and sold in The United States of America as Nissan of Lewisville and/or Lewisville Nissan failed to repair my 2021 Nissan Rogue SV car whose Car Engine broke down and Nissan North America, Inc., and/or Nissan MotorsUSA Corporation had legal duty to repair my said 2021 Nissan Rogue Car within a reasonable time and at their expenses.

As such my 2021 Nissan Rogue Car has not been repaired by Nissan North America, Inc., and/or Nissan MotorsUSA Corporation and/or by their authorized dealer, Nissan of Lewisville and/or Lewisville Nissan till date, I have been looking for another vehicle to purchase on financing from other car dealerships. Lately, I came across another reliable 2023 Ford Escape Car FWD on CarGurus App/website and its lead went to Westway Ford in Irving, TX. Since the said car appeared to be in good condition, I sent a vehicle availability request to the Westway Ford car dealership in Irving, TX from the CarGurus car search App.

Thereafter, I received a phone call from one of the Sales Manager of Westway Ford, Mr. Mathew Winters and I spoke to him about the inquiry on the said 2023 Ford Escape Car that the Westway Ford car dealership had listed it for \$18,500.00 on CarGurus App. I acknowledged making the inquiry on the said Ford Escape car. Mr. Mathew Winters was informed that I work as [REDACTED] with [REDACTED] and that my 2021 Nissan Rogue Car is lying at the Nissan of Lewisville/Lewisville Nissan since August 8, 2025 and the car dealership has refused to repair the said car since then to present

resulting in my loss of work and income and that I will not have any Bank Statement with income in it for a 3 months period to get the car financed and I will be willing to put some money down and that there will be no Cosigner on my Credit Application. Mr. Mathew Winters asked me to submit a Credit Application to their car dealership via a link sent to my email on file with The US NHTSA. I completed the said Credit Application with correct information to the best of my knowledge and belief.

Westway Ford sent me another email to finish the already finished credit application that was already submitted to the Westway Ford and I again submitted the application following their second link sent on my email. A kind of technology oriented harassments from Westway Ford and also asking for 2 Credit Applications instead of 1.

Thereafter, I received another email from their Internet Sales Department asking me to visit the Westway Ford car dealership in Irving, TX. On December 3, 2025, I stopped by at the Westway Ford Car Dealership in Irving, TX and met another car salesperson named Mr. Simba Masters, originating from [REDACTED]. I explained him the details of my 2021 Nissan Rogue Car that is lying unrepaired at the Nissan of Lewisville/Lewisville Nissan since August 8, 2025 and I expressed my urgency to buy another car from Westway Ford to get back to my [REDACTED] work. Mr. Simba gave me his card and I gave him my card to pass it on to Mr. Mathew Winters as Mr. Mathew Winters did not want to meet me due to a prior denial to my car purchase on financing sometimes in the past. Mr. Simba asked me to return to the Westway Ford car dealership on December 4, 2025, which I did and met with another car salesperson named Mr. Jimmie. I told him about all the above details and also told him that without a reliable car, my professional work and professional responsibilities as [REDACTED] on a very [REDACTED] [REDACTED] for other confidential [REDACTED] [REDACTED] is getting hurt and I need to maintain my such never ending ongoing professional responsibilities in law for which I needed a reliable car and I needed it financed and that also urgently as I had purchased my 2021 Nissan Rogue SV Car by paying in full to the used car dealership in Garland, TX.

I also informed Mr. Jimmie that the preowned car will be exempt from the application of the 15 Years Manufacturer's Implied Warranty law if the car is not manufactured and sold by Ford Motors Corporation but the 15 Years Manufacturer's Implied Warranty law will be enforceable on any Ford Car from their car dealership as they are Authorized Ford Car Dealership. On this, he came up with a denial of financing of the car from me as retaliation to my assertion of the 15 Years Manufacturer's Implied Warranty on Ford Car from their dealership.

Some hot words transpired between me and him leading to my letting him know that I will be petitioning The US NHTSA against Westway Ford car dealership for continuously failure to follow the 15 Years Manufacturer's Implied Warranty on all Ford Cars Manufactured and Sold by Ford Motors Corporation since the 4 Federal Court Orders were issued by The United States District Court against Automobile Manufacturers.

I extended a very peaceful and viable options to Mr. Jimmie of Westway Ford to set a precedent for other car manufacturers and car dealerships to follow in the shadow of my Criminal Complaint against Nissan North America, Inc., Nissan MotorsUSA Corporation, Nissan of Lewisville and/or Lewisville Nissan so that at least one car dealership comes in good standing in the eyes of the law and law enforcement but Mr. Jimmie's retaliation forced me to write and file this Criminal Complaint against Westway Ford, Irving, TX with The US NHTSA.

I am filing this Criminal Complaint against Westway Ford, Irving, TX in a written letter instead of filing the same on your website as your website requires a VIN of the vehicle involved whereas, in this situation, I have not been provided a confirmed VIN of the said 2023 Ford Escape Car as only a credit application had been submitted by me with no information on the car provided by Westway Ford. Accordingly, this Criminal Complaint cannot be filed on your government website for technical reasons but it can be filed through a written letter to The US NHTSA.

Since I am at [REDACTED]

and I also have my authorized private practice of law besides working as [REDACTED] with [REDACTED], a reliable car on my clean credit as a means of transportation for me is very eminent and urgently required. Moreover, The City of Southlake, TX has no means of Public Transportation for me to commute from my place of dwelling in Southlake, TX to anywhere I have to go, a reliable car is the only solution and I do not see any reason, whatsoever, that such a reliable car be denied to me or I should be deprived of to have a reliable car, even if it needs to be financed.

The Westway Ford Car Dealership has been in violation of various State and Federal Laws and yet, they are given privileges to operate as a Car Dealership while taking laws in their hands with unclean and dirty hands. This clearly tells me that The Texas Department of Motor Vehicles, Dealership Enforcement Division and their Attorney, Ms. Jennifar Tallant, Attorney At Law has miserably failed to enforce the various Federal Laws effectively in The State of Texas and she has also miserably failed to enforce the various State Laws of The State of Texas in The State of Texas. As an [REDACTED] I am very astonished to see the heights of corruption in The State of Texas which even leave [REDACTED] far behind in Corruption.

Though I got nothing personal against the Attorney of The Texas Department of Motor Vehicles, Ms. Jennifar Tallant or her colleagues, I find it very important to mention it here that The Texas Department of Motor Vehicles, Dealership Enforcement Division has failed to implement and enforce The Federal Laws in The State of Texas on the Automobile Manufacturers and their authorized car dealerships operating in violation of the State and Federal Laws for which their Attorney, Ms. Jennifar Tallant, Attorney at Law stands responsible and criminally liable.

I am writing this Criminal Complaint with The US NHTSA against Westway Ford requesting The US NHTSA as the federal law enforcement agency to permanently cancel and revoke all licenses and privileges of Westway Ford, Enforce a Complete Cease and Desist Operations of all activities, functions, businesses, and rights to operate as a car dealership against Westway Ford anywhere in The State of Texas, anywhere in The United States of America, crush and demolish all assets, vehicles, buildings, properties owned and possessed by Westway Ford as they are willfully

disregarding the federal laws and the federal authorities constituting as Treason Against The United States of America. Further, I am requesting The US NHTSA to arrest everyone in the Westway Ford, Irving, TX who have willfully failed to follow any State and Federal Laws of The Texas State and The US NHTSA and The US Department of The Federal Trade Commission on Soft Credit Pull vs. The Illegal Hard Credit Pull on automobile financing to the customers from their car dealership, wind up their entire business, operations of car purchases, operations of car sales, operations of any other vehicle purchases, operations of any other vehicle sales, operations of any purchase of any parts of any vehicles, operations of any sales of any parts of any vehicles by and at this car dealership, any service provided or offered by Westway Ford, any purchase and sale of any Insurance or Warranty, whether actual or extended warranty offered or provided by Westway Ford, directly and/or indirectly, any service for car repairs, any service for car diagnostics, examination, evaluation, comparison, any internet sales, any solicitation of any vehicle online or at their location any physical car sales at their locations, cancel and revoke all Automotive Financial Licenses of each and everyone who have worked for Westway Ford in the past or currently working for them, arrest the General Manager of Westway Ford, arrest the Owner of Westway Ford, arrest Mr. Mathew Winters, arrest Mr. Jimmie (last name unknown to me) and arrest each and every person of this company who has any involvement or role in purchasing and selling any car or any other vehicle from or for their inventory and at their locations or this car dealership. This company has set up very unhealthy and very disturbing environment for customers and it is hurting thousands of innocent customers who do not know the law and/or have little or less than expected education, training and experience of laws.

The US Government needs to set a precedence in law for the automobile manufacturers and their authorized car dealerships to actually show the enforcement of the Federal Law in The United States of America whereas the Private Businesses are showing to the public that they are above the law.
