THIS DEFECT IN MY OPINION REPRESENTS A SERIOUS POSSIBILITY OF CAUSING A FIRE. GASOLINE IS LEAKING ON TO THE ROAD SURFACE BELOW THE CAR ESPECIALLY WHEN THE TANK IS OVER HALF FULL. CHRYSLER YESTERDAY DECLINED TO REPLACE THE GASOLINE TANK DUE THEY SAID TO THE VEHICLE'S HIGH MILEAGE. A FIRE COULD EASILY START BY A SPARK OR A THROWN CIGARETTE. THE LOCAL DEALER SAID THE THE COST TO REPLACE WOULD BE AROUND \$450.00. I DON'T THINK I SHOULD PAY FOR THIS AS I HAVE DONE NOTHING TO CAUSE IT. THE FAILED PART IS LOCATED ON TOP OF THE FUEL TANK SUCH THAT IT IS PROTECTED FROM ROAD ROCKS, DEBRIS, OR JUST ABOUT ANY CONCEIVABLE HAZARD THAT WOULD BE ENCOUNTERED IN NORMAL OR EVEN HARSH DRIVING CONDITIONS. THIS CAR IS NEVER TAKEN OFF THE HARD ROAD. THANK YOU. *AK
