VEHICLE LESS THAN 6 MONTHS OLD, PROBLEMS WITH BOTH WINDOWS/DOORS. AIR LEAKS FROM BOTH WINDOWS. DOESN'T SEAL PROPERLY, SOUNDS LIKE THE WINDOW IS DOWN SLIGHTLY. DRIVER WINDOW MAKING SQUEAKING NOISE GOING UP AND DOWN AND A CLICKING NOISE IN BOTH DOORS WHEN HITTING SLIGHT BUMPS, BRAKES SQUEALING, DEFECT IN PAINT, AIR VENT SYSTEM, WHEN YOU PUT THE DIAL TO ONLY THE FLOOR AIR STILL COMES OUT OF THE UPPER VENTS. I HAVE HAD THE CAR BACK TO THE DEALERSHIP 5 TIMES. EACH TIME THEY TRIED TO REPAIR THE WINDOWS THEY HAVE CREATED ANOTHER PROBLEM SOMEWHERE ELSE IN THE CAR. THE WINDOWS ARE STILL NOT REPAIRED PROPERLY. THEY REPLACED THE DRIVERSIDE WINDOW, INSIDE DRIVER DOOR PANEL TAKEN OFF AT LEAST 12 OR MORE TIMES, PASSENGER SIDE AT LEAST 4. DASHBOARD TAKEN OUT AT I
